Gardens, continuing along the wall of the said Zoological Gardens, to the West Derby-road; along the middle of that then north-easterly, road, as far as the Newsham Estate; then along the wall of the Newsham Estate, in a south easterly and easterly direction, to the north end of Prospect Vale; then southerly, along the middle of Prospect Vale, to the London-road; then easterly, along the middle of that road, to Stanley-street, and southerly along the middle of Stanley-street, to the end of Birchfield, and along the middle of Birchfield-road, southerly, across Edge-lane, to the Milton-road; then along the middle of the Miltonroad to the boundary of the parish of West Derby; then in a westerly direction, along such parish boundary to the Botanic Gardens, and northerly along the east side of the gardens to Edge-lane; then westerly, along the middle of Edge-lane, to Deane-street, and along the middle of Deane-street, northerly, to the London-road; then westerly, along the middle of the London-road and Kensington, to Low Hill, to the point where the boundary line of the said District Chapelry of Fairfield commenced, and as the same is more particularly delineated on the map or plan hereunto annexed, and thereon coloured pink.

"Your Majesty's said Commissioners beg leave further to represent that it also appears to them to be expedient that banns of marriage should be published and that marriages, baptisms, and churchings should be solemnized or performed in the said church of Saint John the Divine, at Fairfield aforesaid; and that the fees to arise therefrom should belong and be paid to the minister or incumbent of such church for the time being.

"That the consent of the Right Reverend

"That the consent of the Right Reverend John, Bishop of the said diocese of Chester, has been obtained thereto, as required by the Acts and sections hereinbefore mentioned, in testimony whereof he has signed and sealed this representation.

"Your Majesty's said Commissioners therefore humbly pray that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such Order in respect thereto as to your Majesty, in your royal wisdom, shall seem meet."

Her Majesty having taken the said representation, together with the map or plan thereunto annexed, into consideration, was pleased, by and with the advice of her Privy Council, to approve thereof, and to order, as it is hereby ordered, that the proposed assignment of a district chapelry to the said consecrated church of Saint John at Fairfield, in the parish of West Derby, be accordingly made, and the recommendations of the said Commissioners in respect of the publication of banns and the solemnization of marriages, baptisms, and churchings in the said church, and in respect of the fees to arise therefrom, be carried into effect agreeably to the provisions of the said Acts; and Her Majesty is further pleased to direct that this Order be forthwith registered by the registrar of the diocese of Chester.

WHEREAS Her Majesty's Commissioners for building new churches have, in pursuance of the sixteenth section of an Act, passed in the the north-eastern corner of Offord-road, and pro-

fifty-ninth year of the reign of His Majesty King George the Third, intituled "An Act to amend "and render more effectual an Act passed in the last session of Parliament for building and pro-"moting the building of additional churches in " populous parishes," and in the twelfth section of an Act, passed in the session of Parliament, held in the first and second years of Her Majesty's reign, intituled "An Act to amend and render "more effectual the Church Building Acts," and in the third section of an Act, passed in the session of Parliament, held in the second and third years of Her Majesty's reign, intituled "An Act to make better provision " for the assignment of ecclesiastical districts to " churches or chapels augmented by the Governors " of the Bounty of Queen Anne, and for other purposes," and in the first section of an Act, passed in the session of Parliament held in the third and fourth years of Her Majesty's reign, intituled "An Act to further amend the Church "Building Acts," or of any other powers in that behalf contained in the Church Building Acts, duly prepared and laid before Her Majesty in Council, a representation, bearing date the seventh day of March, one thousand eight hundred and fifty-four, in the words following, viz.:

"Your Majesty's Commissioners for building new churches beg leave humbly to represent, that having taken into consideration all the circumstances of the district parish of the Holy Trinity Islington, in the county of Middlesex, and in the diocese of London, it appears to them to be expedient that a particular district should be assigned to the consecrated church of Saint Andrew, situate in Thornhill-square, in the said district parish of the Holy Trinity Islington, under the power or authority contained in the sixteenth section of an Act of Parliament, passed in the fifty-ninth year of the reign of His Majesty King George the Third, intituled 'An Act to amend and render more effectual an Act, passed in the last session of Parliament, for building and pro-'moting the building of additional churches in 'populous parishes,' and in the twelfth section of an Act of Parliament, passed in the first and second years of your Majesty's reign, intituled An Act to amend and render more effectual the 'Church Building Acts,' and in the third section of an Act of Parliament, passed in the second and third years of your Majesty's reign, intituled 'An Act to make better provision for the assign-'ment of ecclesiastical districts to churches or 'chapels augmented by the Governors of the Bounty of Queen Anne, and for other purposes,' and in the first section of an Act of Parliament, passed in the third and fourth years of your Ma-jesty's reign, intituled 'An Act to further amend the Church Building Acts,' or of any other powers in this behalf, contained in the Church Building Acts, and that such proposed district should comprise a portion of the said district parish of the Holy Trinity Islington, and also a portion of the district chapelry, called All Saints District (heretofore assigned out of such district parish), and should be named or called 'The District Chapelry of Saint Andrew Islington,' and that the boundaries thereof should be those hereinafter mentioned; that is to say:

"Bounded on the west by the parish of Saint Pancras, on the north and north-east by the District Chapelry of Saint James Lower Holloway, on the east by the remaining part of the district parish of the Holy Trinity Islington, from which the said district chapelry of Saint Andrew Islington is separated by a line commencing at the north-eastern corner of Offord-road, and pro-
