Provisional Order.

Brough and Middleton Road.

WHEREAS the Trustees of the Brough and Middleton Turnpike Road, acting under the powers of the Local Act of the 57th of George the Third, cap. 45, have made application to Her Majesty's Principal Secretary of State for the Home Department, pursuant to the Act of the session holden in the 14th and 15th years of the reign of Her present Majesty, cap. 38, for a Provisional Order upon the terms following; viz. :—

To reduce the rate of interest on the mortgage debt charged or secured on the tolls or revenues of the said road from the sum of five pounds per centum per annum to the sum of one penny per centum per annum, and to extinguish the whole of the arrears of interest due upon the said debt.
