The QUEEN'S Most Excellent Majesty in Council.

HEREAS there was this day read at the Board, a Report from the General Board of Health, dated the twenty-second day of April, one thousand eight hundred and fifty-four, in the words following; that is to say:

"To the Queen's Most Excellent Majesty.

"We, the General Board of Health, appointed for the purposes of 'The Public Health Act, 1848.' have, in pursuance of the provisions of that Act, upon the petition of not less than one-tenth of the inhabitants rated to the relief of the poor of and within the parish of Arnold, in the county of Nottingham (the number of the said petitioners greatly exceeding thirty in the whole), directed William Lee, a Superintending Inspector, appointed for the purposes of the said Public Health Act, to visit the said parish, and to make inquiry, and to examine witnesses as to the sewerage, drainage and supply of water, the state of the burial-grounds, the number and sanitary condition of the inhabitants, and as to any local Acts of Parliament in force within such parish for paving, lighting, cleansing, watching, regulating, supplying with water, or improving the said parish, or having relation to the purposes of the said Public Health Act; also as to the natural drainage areas, and the existing municipal, parochial, and other local boundaries, and the boundaries which might be most advantageously adopted for the purposes of that Act;

"And the said Superintending Inspector, having previously given the notices directed by the said Public Health Act, proceeded upon the said inquiry in the manner directed by that Act, and hath reported in writing to the said Board upon the said several matters with respect to which he was directed to inquire, and upon certain other matters with respect to which he deemed it expedient to report for the purposes of that Act;

"And copies of the said report, accompanied by a notice, stating that written statements might be forwarded to the said Board with respect to any matter contained in or omitted from the said report, or any amendment proposed to be made therein, have been duly published and deposited as directed by the said Public Health Act, and the time for forwarding such statements has now elapsed, and all such statements as have been received by the said Board have been duly deposited as required by the aforesaid Act;

"And it appears by the said report, that there is no local Act of Parliament in force within the said parish, for paving, lighting (otherwise than for the profit of proprietors or shareholders), cleansing, watching, regulating, supplying with water, or improving such parish, or any part thereof, or in anywise relating to the purposes of the said Public Health Act;

"Now, therefore, we, the said General Board of Health, do hereby, in pursuance of the said Public Health Act, humbly report to your Majesty that it appears to us to be expedient that:

"1. 'The Public Health Act, 1848,' and every part thereof, except the section numbered 50 in the copies of that Act, printed by your Majesty's printers, should be applied to and be in of the said parish of Arnold, in the county of Nottingham, and that such area, places, and parts of places should be and constitute a district for the purposes of the said Public Health Act accordingly.

"2. The Local Board of Health to be elected under the said Public Health Act should consist of nine persons, and that the entire number should be elected for the whole of the said district.

"3. The first election of the said Local Board of Health should take place on the fifteenth day of June, in the year of our Lord, one thousand

eight hundred and fifty-four.


"4. One-third in number of the said Local Board of Health should go out of office on the thirty-first day of March in each year subsequently to that in which the said first election of that Local Board takes place; but in case the day so appointed should fall on a Sunday, or on a day appointed for public fast or thanksgiving, then that such one-third should go out of office on the day next following.

"5. Every person at the time of his election as member of the said Local Board, and so long as he shall continue in office by virtue of such election, should be resident, as in the said 'Public Health Act, 1848,' is required, and be seized or possessed of real or personal estate, or both, to the value or amount of not less than three hundred and fifty pounds, or should be so resident, and rated to the relief of the poor of some parish, township, or place, of which some part is within the said district, upon an annual value of not less than six pounds.

"6. At the first election of the said Local Board, Thomas Frost, of Arnold, Lace Manufacturer, should have the powers and perform the duties vested in or imposed upon the chairman of the Local Board of Health by 'the Public Health Act, 1848,' in relation to the election by owners of property and rate payers, and should perform all other duties which it may be requisite for him to perform in conducting and completing the said first election; and in case the said Thomas Frost, from illness, or other sufficient cause, should be unable to exercise or discharge such powers or duties, or should be absent, or should refuse to act, then that Joseph Phipps, Registrar of Births and Deaths, of Arnold aforesaid, should exercise and perform such of the said powers and duties as then remain to be exercised or performed.

"7. The fourteen days' notice of qualification, required by 'The Public Health Act, 1848, to be given by owners of property, in order to entitle them to vote at the said first election, sliggld be given to the said Thomas Frost, at his residence, Arnold; or in case he should refuse, or be unable to receive the same, then to the said Joseph Phipps, at his residence, Frontstreet, likewise within the district of Arnold aforesaid.

Now, therefore, Her Majesty having taken the said Report into consideration, is pleased to apforce within and throughout the entire area, places, prove thereof, and by and with the advice of Her and parts of places comprised within the boundaries | Privy Council, doth, hereby, under and in pursuance of the "Public Health Act, 1848," order and direct that:

1. six pounds.

WHEREAS many English workmen have lately proceeded to France in search of employment, and having failed in obtaining work of any description, have fallen into great poverty and distress, and have suffered much misery and privation: all such persons, intending to go over to France for the same purpose, are hereby cautioned and warned of the inconvenience to which they will be exposed, unless they shall have entered beforehand into some contract or engagement with some person in France, who is able to employ them; or unless they shall, before leaving their own country, have provided themselves with funds sufficient to preserve them from want while abroad, and to enable them to return, if they cannot find the employment they have sought for.

THE Right Honourable the Lords of the Committee of Privy Council for Trade and Plantations have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Chargé d'Affaires at Stockholm, enclosing a Declaration which has been issued by the King of Sweden, for the guidance of the trade and navigation of that country in times

of war between Foreign Powers, a translation of which is hereunto subjoined.

WE, Oscar, by the grace of God, King of Sweden and Norway, &c., recognizing the necessity, in the face of the collisions threatening to take place between foreign maritime Powers, of the rigorous observance by our faithful subjects engaged in trade and navigation, of the obligations and precautions requisite to ensure to the Swedish Flag all the rights and privileges appertaining to it, in its quality of neutral, and also with a view to avoiding everything that might render it in any way suspected by the Belligerent Powers, and exposed to insult, have judged it expedient, in repealing previous orders on the subject, to decree that the following rules shall be generally observed in future: -

- 1. In order to be admitted to enjoy the rights and privileges accruing to the Swedish Flag, in its neutral quality, every Swedish vessel must be furnished with the documents which, by existing Ordinances,* are required to prove its nationality, and these documents must always be on board the vessel during its voyages.
- 2. Captains are strictly forbidden to have double or false papers and bills of lading, or to hoist foreign colours on any occasion or under any pretext
- 3. If, during the stay of a Swedish vessel at a foreign port, the crew, whether by desertion, death, illness, or any other cause, should be so diminished as not to be sufficient for the working of the vessel, and foreign sailors should be therefore engaged, the preference must be given to the subjects of Neutral Powers; but in any case the number of the subjects of the Belligerent Powers on board the ship must not exceed one-third of the total Every change of this nature in the crew of the ship, with the causes which have led to it, must be marked by the Captain in the ship's books, and the fidelity of the annotation certified by the proper Swedish Consul or Vice-Consul, or if there be no such person at the spot, by the civil authorities, the Notary Public, or some other person of the same authority, pursuant to the customs of the respective Countries.

4. The Swedish vessels in their neutral quality may navigate freely to the ports and on the coasts of the nations at war; but the Captains must abstain from all attempts to enter a blockaded port, as soon as they have been formally warned of the state of that port by the officer commanding the blockade.

By a blockaded port, is meant a port which is closed by one or more of the enemies' vessels of war, stationed so near, that it cannot be entered

without evident danger. 5. All merchandize, including property of subjects of the Belligerent Powers, may be freely carried on board Swedish vessels in their quality of neutrals, with the exception of contraband of war. By contraband of war, are meant the following articles: "cannons, mortars, arms of all sorts, bombs, grenades, balls, flints, matches, gunpowder, saltpetre, brimstone, cuirasses, pikes, belts, curtouch-boxes, saddles, and bridles, as well as all articles directly serving for warlike purposes,"-excepting always such a quantity of those articles as may be necessary for the defence of the ship and the crew.

In case any changes or additions should be made in the definition of articles composing contraband of war, consequent upon conventions with

Foreign Powers, further notifications will be issued.

6. Every Swedish Captain is forbidden to employ the vessel which he commands, in the transport, for any of the Belligerent Powers, of despatches, troops, or munitions of war, without being forcibly compelled. In this case he should protest formally against such an employment of force.

7. The ships of the Belligerent Powers may import into, and export from, the ports of Sweden, all commodities and merchandize, provided their importation or exportation be permitted by the general Custom House Tariff, with the exception

of articles reputed centraband of war.

8. All Swedish subjects are forbidden to arm or equip vessels, as Privateers, against any of the Belligerent Powers, their subjects, and property, or to take part in the equipment of vessels intended for that purpose. They are equally forbidden to serve on board any Foreign Privateer.

9. No Foreign Privateer shall be allowed to enter a Swedish port, or to stay in our roads. Prizes are not to be taken into Swedish ports, except in cases of proved distress. Our subjects are also forbidden to buy captured effects of any

kind from Foreign Privateers.

10. When a Captain, sailing without escort, is met in open sea by any vessel of war of one of the Belligerent Powers having right to examine his ship's papers, he must neither refuse nor endeavour to avoid the search, but is bound to produce his papers loyally and without evasion, and to take care that none of the documents concerning the ship or its cargo be abstracted or thrown into the sea, either after the vessel is hailed, or during the search.

11. When merchant vessels sail under escort of

vessels of war, the Captains must act in conformity with the prescriptions of the Royal Ordi-

nance of 10th June, 1812.

12. The Captain who observes scrupulously all the above regulations is entitled to enjoy, in accordance with treaties and the law of nations, a free and uninterrupted navigation, and if he be, notwithstanding, molested, he has a right to expect the most energetic support on the part of our Ministers and Consuls abroad in all his just attempts to obtain reparation and indemnification, whereas the Captain who omits or neglects to observe what is above prescribed for his guidance, will only have himself to blame for the unpleasant consequences of his negligence, without hope of our support and protection.

13. In case of the scizure of a Swedish vessel. the Captain should remit to the Swedish Consulor Vice-Consul, if there be one in the port where his ship has been brought, or, in default, to the nearest Swedish Consul or Vice-Consul, a faithful and duly certified report of the circumstances of the capture, with all its details.

We direct and order all those whom it may concern to conform themselves exactly to the above. In faith of which we have signed the present with our hand and have affixed thereto our royal scal.

THE Right Honourable the Lords of the Committee of Privy Council for Trade and Plantations have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Minister at Berlin, inclosing the subjoined translation of a Royal Ordinance of the King of Prussia respecting the duty to be levied on the importation of foreign syrup.

(Translation.)

WE, Frederic William, by the grace of God, King of Prussia, &c. A further agreement having been concluded between the Governments of the States of the Zollverein, relative to carrying out the arrangements for the duties on foreign syrups, do, with the assent of the Chambers, decree as follows:

§ 1. The duty of two thalers per centner on foreign syrup, prescribed by the ordinance of the lith of June, 1853 (Gesetz-Sammlung, p. 441), from the 1st of January, 1854, to the end of August, 1855, shall apply only to ordinary syrup, that is to say, to such as, according to the result of the tests which are to be directed for this purpose by the Customs' authorities, contains no crystallizable sugar, or only a small quantity. Any syrup which is found to be incompatible with the terms of the aforesaid rule, shall be charged with the import duty of four thalers per centner.

§ 2. This order shall be applicable to all the clearances already effected, from the 1st of

January, 1854. § 3. Our Minister of Finances is charged with

the execution of the present law.
