I HAVE the honour to request that you will be pleased to move Rear-Admiral James Hanway Plumridge to bring under the notice of the Commander-in-Chief the extremely gallant conduct of Mr. Henry Hugh Monk Magrath, midshipman, in the pinnace of this ship on the occasion of an attack on Gamla Carleby, on the night of the 7th instant, who, whilst loading the 12-pounder for the fifteenth time, was struck down by a severe wound from a musket-ball, and removed to the stern sheets, where it was bound up, and he was then only prevented from attempting to resume his former duty by the express order of Lieutenant Fellowes, commanding the boat.

The QUEEN's Most Excellent Majesty in Council.

W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act passed in the session of Parliament held in the third and fourth years of Her Majesty's reign, intituled "An Act to carry into effect, with cer-"tain modifications, the fourth report of the "Commissioners of Ecclesiastical Duties and "Revenues," duly prepared and laid before Her Majesty in Council a scheme, bearing date the eleventh day of May, in the year one thousand eight hundred and fifty-four, in the words and figures following, that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the third and fourth years of your Majesty's reign, intituled 'An Act 'to carry into effect, with certain modifications, 'the fourth report of the Commissioners of Ecclesi-'astical Duties and Revenues,' have prepared and now humbly lay before your Majesty in Council, the following scheme for making further provision for the cure of souls in the new parish of Saint John the Evangelist, Limehouse, in the diocese of London.

"Whereas by a duly gazetted Order of your Majesty in Council, bearing date the eighth day of Arugust, one thousand eight hundred and fiftythree, ratifying a scheme prepared by us under the provisions of the said Act, it was provided that there should thereafter be paid by the rector for the time being of the benefice or rectory of Saint Andrew Undershaft with Saint Mary Axe thereunto annexed, in the city and diocese of London, out of the revenues thereof, by equal half-yearly payments on the twenty-fifth day of March and twenty-ninth day of September in every year, to the Governors of the Bounty of Queen Anne, by their treasurer for the time being, but in trust for the perpetual curates, incumbents, or ministers for the time being of the new parishes and districts

enumerated in a schedule to the said Order annexed (of which the said new parish of Saint John the Evangelist, Limehouse, is one), the annual sum of four hundred and seventy-five pounds, clear of all deductions except income or property tax, and that such annual sum of four hundred and seventy-five pounds, and each and every instalment thereof, should be charged upon all the tithes or the payments in lieu or in respect of tithes payable by virtue of the Act passed in the thirty seventh year of the reign of His late Majesty King Henry the Eighth, chapter twelve, to the rector for the time being of the said rectory : And that the said annual sum of four hundred and seventy-five pounds should be divided and distributed in the manner in such Order mentioned, and so as, inter alia, to secure to the incumbent for the time being of the said new parish of Saint John the Evangelist, Limehouse, the annual sum of one hundred and seventy-five pounds.

"And whereas the Right Honourable and Right Reverend Charles James, Bishop of London, the patron of the said benefice or rectory, and the Reverend Frederick George Blomfield, incumbent of the same, are desirous that the annual sum of one hundred and seventy-five pounds, now payable as aforesaid, to the incumbent of the said new parish of Saint John the Evangelist, Limehouse, should be increased to the annual sum of two hundred pounds in manner hereinafter mentioned.

"Now, therefore, we humbly recommend and propose with the consent of the Right Honourable and Most Reverend John Bird, Archbishop of Canterbury, and of the said Charles James, Bishop of London, and Frederick George Blomfield, in testimony whereof, they have respectively signed and sealed this scheme, that the sum of four hundred and seventy-five pounds so as aforesaid charged on the said benefice or rectory of Saint Andrew Undershaft with Saint Mary Axe shall henceforth be increased to the yearly sum of five hundred pounds, and that thereupon the yearly sum of one hundred and seventy-five pounds so to be paid as aforesaid to the incumbent of the new parish of Saint John the Evangelist, Limehouse, shall be increased to two hundred pounds.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said firstmentioned Act or of any other Act of Parliament."

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law, immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the diocese of London.
