THE Right Honourable the Lords of the Committee of Privy Council for Trade and Plantations have received, through the Secretary of State

for Foreign Affairs, a copy of a Despatch from Her Majesty's Minister at Washington, inclosing the copy of a circular instruction from the United States Treasury to the Collectors of Customs, directing the issue of Receipts to parties paying duties, under the present state of the American Law, on British caught fish. In being in contemplation to make the action of Congress at its next session available retrospectively for the remission of the duty on British caught fish, taken during the present fishing season; this measure is intended to facilitate the arrangement contingent on the expected action of Congress, by enabling the importers on the presentation of these receipts to obtain a repayment of their amounts, so soon as the contemplated Act of Congress shall have been passed.

THE Right Honourable the Lords of the Committee of Privy Council for Trade and Plantations have received, through the Secretary of State for Foreign Affairs, a copy of a Letter, which had been addressed to Her Majesty's Minister at Naples, by Mr. Goodwin, reporting the imposition of a 7 days' quarantine of observation on vessels arriving at Palermo from the undermentioned ports, not including the term of passage, provided such a voyage shall have been free from death on board; viz.: Stockholm, Hamburgh, Altona, the ports on the Elbe, Lubeck, Travemund, the Scandinavian Kingdom, Spain, Smyrna, Syra, Scalanova, Constantinople, Gallipoli, Paros, Nio, Gothland, St. Petersburg, Cronstadt, Revel, London, Liverpool, Glasgow, Belfast, the Isle of Cristina (Cambræs), Isle of Arran, Venice, Sardinia, Gibraltar, Marseilles, Toulon, Cette, Algiers.

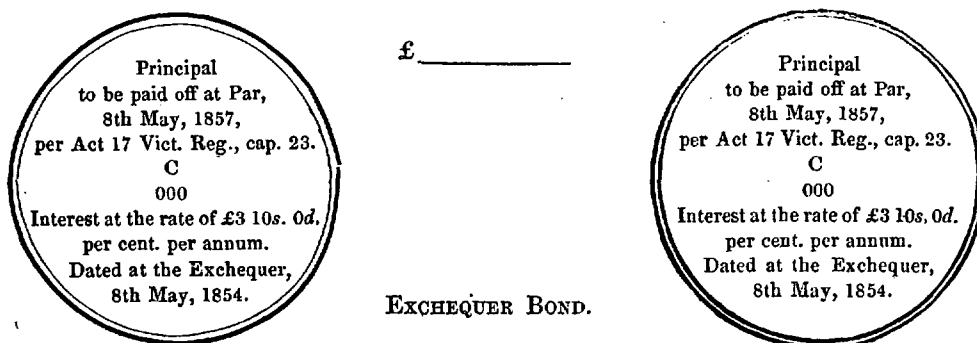

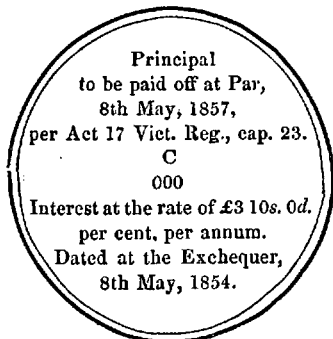

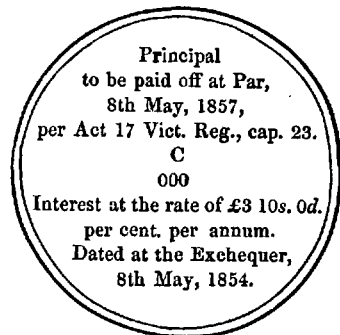

**Cape Town Railway and Dock Company
Incorporation.**

the responsibility of the shareholders in the said undertaking to the amount of their shares respectively, and to confer on the said Railway and Dock Company the power to take and hold lands for any term of years, or in perpetuity, for the purposes of such undertakings, or of any of them, in the said colony, or in Great Britain; and also powers and facilities for making, enforcing, and recovering calls, creating, increasing, reducing, and transferring scrip, and other shares, mortgages, debentures, and other like instruments and securities, cancelling existing shares, consolidating or converting shares into stock, increasing the capital of the said Company, raising and borrowing money by mortgage or otherwise; also for paying interest during the construction of the works, or any of them; and also for levying tolls, dues, rates, and duties in respect of the use of the railways, docks, and any extensions of railways or docks belonging to or to belong to the said Company. Together with such powers as may be necessary for protecting the rights of the shareholders, and the remittance or payment of dividends or interest with respect to any share or shares, or other interest in the said undertaking, either in the said colony or in Great Britain, and for all or any of the purposes aforesaid, and for other purposes.

Bridport Railway.

(Powers to construct a Railway from Bridport to Maiden Newton, on the Wilts, Somerset, and Weymouth Railway; Arrangements with the Great Western Railway Company as to Working, Traffic, and Tolls; Amendment of Acts.)
