THE Earl of Clarendon has received from Her Majesty's Ambassador at the Court of France a copy of a Note addressed to his Excellency by M. Drouyn de Lhuys, Minister for Foreign Affairs, on the 19th instant, of which the following is a copy and translation :

MONSIEUR L'AMBASSADEUR,

J'AI eu l'honneur de recevoir la lettre par laquelle Votre Excellence a bien voulu me communiquer le texte des Résolutions identiques adoptées par les deux chambres du Parlement Britannique dans leur séance du 19 de ce mois.

Les remerciements votés à notre armée et à notre flotte, ainsi qu'à leurs chefs, ne pouvaient que toucher vivement le Gouvernement de l'Empereur. C'est avec une sollicitude de tous les instants que la pensée de Sa Majesté Impériale se reporte sur le théâtre de la lutte dans laquelle sont engagées les armées alliées ; c'est donc avec une profonde satisfaction qu'elle voit les soldats des deux pays grandir dans leur estime mutuelle par le courage et la persévérance qu'ils déploient au service d'une même cause. Le Gouvernement de l'Empereur se félicite surtout de voir dans le vote du Parlement un témoignage de l'intime union qui, liant la politique de la France et de l'Angleterre, confond aussi dans une même expression les éloges que de glorieux efforts et de laborieux travaux valent si justement aux deux armées et aux deux marines que les deux pays ont envoyées partager les mêmes périls et les mêmes fatigues.

M. L'AMBASSADEUR,

I HAVE had the honour to receive the letter by which your Excellency was good enough to communicate to me the text of the identic Resolutions adopted by the two chambers of the British Parliament in their session of the 19th instant.

The thanks voted to our army and to our fleet, as well as to their commanders, could not but deeply affect the government of the Emperor. The thoughts of His Imperial Majesty are directed

with unceasing solicitude to the scene of the contest in which the allied armies are engaged ; it is, therefore, with the utmost satisfaction that he observes the esteem which the soldiers of the two countries mutually entertain for each other increased by the courage and perseverance which they display in the service of one and the same cause. The Government of the Emperor especially congratulates itself at perceiving in the vote of the Parliament, an evidence of the intimate union which, connecting together the policy of France and England, blends also in one and the same expression the encomiums to which glorious efforts and toilsome labours so justly entitle the two armies and the two fleets which the two countries have sent to share the same perils and the same fatigues.

jesty's Principal Secretaries of State, I do by this Provisional Order under my hand declare, subject to the confirmation hereof by Parliament, that the rate of interest shall be reduced from five pounds to three pounds per centum, per annum, from the thirtieth day of November, one thousand eight hundred and fifty-four, in respect to the sum of one thousand pounds, and from the twenty-sixth day of December, one thousand eight hundred and fifty-four, in respect to the sum of one thousand five hundred pounds, being the preference mortgage debts; also that from the first day of July, one thousand eight hundred and fifty-four, the rate of interest shall be reduced from five pounds to one penny per centum, per annum, upon the remaining debt of eight thousand and twenty pounds, charged or secured upon the tolls or revenues of the said road; and that the whole of the arrears of interest due and remaining unpaid, on the first day of July last, upon the said debt of eight thousand and twenty pounds, shall be extinguished.
