The registry of county courts' judgments was established to afford to traders a ready means of ascertaining the solvency of parties, and to enable executors and administrators to discover what judgment debts they are bound to satisfy.

In the registry can be found the name, address, and occupation of every party against whom a judgment has been recorded since March, 1847, in any of the county courts throughout England and Wales, for £10 and upwards, and which remains unsatisfied at the time the search is made.

Also the name, last address, and occupation of every party who has applied for protection from his creditors to any of the county courts since June, 1854.

Nottingham and Newhaven Road.

(Continuance of Term, Abandonment of Portions of Road.)

NOTICE is hereby given, that the trustees of the Nottingham and Newhaven Turnpike Road, in the counties of Nottingham and Derby, who are applying to Parliament in the present session for an Act for continuing the term of the several Acts of Parliament relating to the said road, and for authorizing the abandonment of certain parts or portions of the said road, and for other purposes, intend applying to Parliament, in the present session, by petition, for additional provision to enable them to introduce into the said intended Act so pending in Parliament, provisions authorizing the abandonment of a certain further part or portion of the road comprised in the first district of the said Nottingham and Newhaven Road, the intention to abandon which was not included in the Notices published in the month of November last of the intention to apply for the said intended Act.
