

district, upon an annual value of not less than ten pounds.

6. At the first election of the said Local Board, Thomas Thring, of Wilton, shall have the powers and perform the duties vested in or imposed upon the chairman of the Local Board of Health by "The Public Health Act, 1848," in relation to the election by owners of property and ratepayers, and shall perform all other duties which it may be requisite for him to perform in conducting and completing the said first election; and, in case the said Thomas Thring, from illness, or other sufficient cause, shall be unable to exercise or discharge such powers or duties, or shall be absent, or shall refuse to act, then that John Swayne, of Wilton aforesaid, shall exercise or perform such of the said powers and duties as then remain to be exercised or performed.

7. The fourteen days' notice of qualification required by "The Public Health Act, 1848," to be given by owners of property, in order to entitle them to vote at the said first election, shall be given to the said Thomas Thring, at his residence, West-street, Wilton; or in case he shall refuse, or be unable to receive the same, then to the said John Swayne, at his residence, likewise within the district of Wilton aforesaid.

WHEREAS by an Act, passed in the session of Parliament, held in the fifteenth and sixteenth years of Her Majesty's reign, intituled "An Act to amend the laws concerning the burial of the dead in the metropolis," it is enacted, that in case it appears to Her Majesty in Council, upon the representation of one of Her Majesty's Principal Secretaries of State, that, for the protection of the public health, burials in any part or parts of the metropolis, or in any burial-grounds or places of burial in the metropolis, should be wholly discontinued, or should be discontinued subject to any exception or qualification, it shall be lawful for Her Majesty, by and with the advice of Her Privy Council, to order that from and after a time mentioned in the Order, burials in such part or parts of the metropolis, or in such burial-grounds or places of burial, shall be discontinued wholly or subject to any exceptions or qualifications mentioned in such Order, and so from time to time, as circumstances may require;

And whereas Her Majesty has been pleased by certain Orders in Council to extend the time for discontinuing burials in the Upper Burial-ground, of the parish of Putney, and in the churchyard of the parish of St. Luke, Charlton, in the county of Kent, and in the churchyards of St. Giles and St. George, Camberwell;

And whereas the Right Honourable Sir George Grey, Bart., one of Her Majesty's Principal Secretaries of State, has made a representation stating that he is of an opinion that the time for closing the said churchyards and burial-ground may be further extended;

Now, therefore, Her Majesty, having taken the said representation into consideration, is pleased by and with the advice of Her Privy Council, to order, and it is hereby ordered, that burials be discontinued in the Upper Burial-ground of the

parish of PUTNEY, and in the churchyard of the parish of ST. LUKE CHARLTON, in the county of Kent, from and after the first of JUNE, and in the churchyards of St. Giles and St. George CAMBERWELL, from and after the first September, instead of from the first March, one thousand eight hundred and fifty-five.

WHEREAS by an Act, passed in the session of Parliament, held in the seventeenth and eighteenth years of Her Majesty's reign, intituled "An Act to amend the laws concerning the burial of the dead in England, beyond the limits of the metropolis, and to amend the Act concerning the burial of the dead in the metropolis;" it is, amongst other things, enacted, that in case it appears to Her Majesty in Council, upon the representation of one of Her Majesty's Principal Secretaries of State, that for the protection of the public health, burials in any city or town, or within any other limits, or in any burial-ground or places of burial, should be wholly discontinued, or should be discontinued subject to any exemption or qualification; it shall be lawful for Her Majesty, by and with the advice of Her Privy Council, to order that after a time mentioned in the Order, burials in such city or town, or within such limits, or in such burial-grounds or places of burial, shall be discontinued wholly, or subject to any exceptions or qualifications mentioned in such Order, and so from time to time as circumstances may require;

And whereas Her Majesty has been pleased, by various Orders in Council to direct that burials should be discontinued in the churchyards and burial-grounds hereinafter mentioned;

And whereas the Right Honourable Sir George Grey, Bart., one of Her Majesty's Principal Secretaries of State, has made certain representations stating that he is of opinion that the time for closing the said churchyards and burial-grounds may be extended;

Now, therefore, Her Majesty, having taken such representations into consideration, is pleased by and with the advice of Her Privy Council to order, and it is hereby ordered, that burials be discontinued in the undermentioned churchyards and burial-grounds as follows, viz.:

In the parish churchyard of BOLTON, in the county of Lancaster, and in the churchyards of St. George, the Holy Trinity, All Saints, Christ Church, and Emmanuel Church, and in the burial-grounds of the following chapels, namely, the Baptist Chapel Moor-lane, the Wesleyan Chapel Bridge-street, the Wesleyan Chapel Fletcher-street, the Roman Catholic Chapel St. Peter and St. Paul Pilkington-street, the Independent Chapel Mawdsley-street, Albert-place Chapel, the Independent Methodist Chapel Fold's-road, the Primitive Methodist Chapel Higher Bridge-street, the Unitarian Chapel Deans-gate, and the Refugee Chapel Hanover-street, in the Ridgway Gates Wesleyan Burial-ground, and in the Quakers' Burial-ground, all in the said borough of Bolton, from and after the first October, instead of from the first March, one thousand eight hundred and fifty-five.
