PRESENT.

The QUEEN's Most Excellent Majesty in Council.

HEREAS Her Majesty's Commissioners for building new churches have, in pursuance of the sixteenth section of an Act of Parliament, passed in the fifty-ninth year of the reign of His Majesty King George the Third, intituled "An Act to amend and render more "effectual an Act passed in the last session of "Parliament for building and promoting the building of additional churches in populous "parishes," and of the third section of an Act, passed in the session of Parliament holden in the second and third years of Her Majesty's reign, intituled "An Act to make better provision for the assignment of ecclesiastical districts to "churches or chapels augmented by the Gover-"nors of the bounty of Queen Anne, and for "other purposes," duly prepared and laid before Her Majesty in Council a representation, bearing date the twentieth day of March, one thousand eight hundred and fifty-five, in the words following; viz.:

"Your Majesty's Commissioners for building new churches beg leave humbly to represent that, having taken into consideration all the circumstances of the parish of Streatham, in the county of Surrey, and in the diocese of Winchester, it appears to them to be expedient that a particular district should, be assigned to the consecrated church of Emmanuel, situate at Streatham Common, in the said parish of Streatham, under the power for this purpose contained in the sixteenth section of an Act of Parliament, passed in the fifty-ninth year of the reign of His Majesty King George the Third, intituled 'An Act to amend and render more effectual an Act passed in the last session of Parliament for building and pro-'moting the building of additional churches in · populous parishes,' and in the third section of an Act of Parliament, passed in the second and third years of your Majesty's reign, intituled 'An Act to make better provision for the assignment of ecclesiastical districts to churches or 'chapels, augmented by the Governors of the bounty of Queen Anne, and for other purposes,' and that such proposed district should be named The District Chapelry of Emmanuel Streat-

ham,' and that the boundaries thereof should be those hereinafter mentioned; that is to say:

"The district chapelry of Emmanuel Streatham is bounded on the north-west by the parish of Mitcham, on the south-west and south-east by the parish of Croydon, on the east by the parish of Lambeth, and on the north by the remaining part of the parish of Streatliam, from which the said district chapelry of Emmanuel Streatham is separated by a line commencing in Crown-lane at the point where the boundary of the parishes of Streatham, Croydon, and Lambeth meet, and proceeding from such point westerly along the middle of Crown-lane as far as the eastern enclosure of Park-hill House and grounds; then proceeding north-easterly, westerly, and south-westerly along such enclosure to the northern enclosure of Hill House; then westerly along such enclosure until it reaches the northern side of the common, then westerly along the northern side of the said common as far as the high road to London; then northerly up the middle of that road as far as Manor Park-road; then westerly along the middle of Manor Park-road as far as the western fence of Manor Park; then northerly along the western fence of Manor Park as far as Mitcham-lane; then proceeding south-westerly along the middle of that lane until it reaches the boundary-line separating the said parish of Streatham from the said parish of Mitcham, as such district chapelry of Emmanuel Streatham is more particularly delineated on the map or plan hereunto annexed, and thereon tinted or edged round with pink.

- "Your Majesty's said Commissioners beg leave further to represent that it also appears to them to be expedient that banns of marriage should be published, and that marriages, baptisms, and churchings, should be solemnized or performed at Emmanuel Church aforesaid, and that the fees to arise therefrom should be paid and belong to the incumbent of that church for the time being.
- "That the consent of the Right Reverend Charles Richard, Bishop of the said diocese of Winchester, has been obtained thereto, as required by the Acts and sections hereinbefore mentioned, in testimony whereof he has signed and sealed this representation.
- "Your Majesty's said Commissioners therefore humbly pray that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such order in respect thereto as to your Majesty in your royal wisdom shall seem meet."

Her Majesty having taken the said representation, together with the map or plan thereunto annexed, into consideration, was pleased, by and with the advice of her Privy Council, to approve thereof, and to order, and it is hereby ordered, that the proposed assignment of a chapelry district to the consecrated church of Emmanuel, situate at Streatham Common, in the said parish of Streatham, be accordingly made, and that the recommendations of the said Commissioners, in respect of the publication of banns, and the solemnization of marriages, baptisms, and churchings, in the said church, and the fees to arise therefrom, be carried into effect, agreeably to the provisions of the said Acts; and Her Majesty is further pleased to direct that this Order be forthwith registered by the Registrar of the diocese of Winchester.
