

CRICKHOWEL, BRECON.—To be discontinued forthwith in the *church*, and in the *churchyard* except so far as is compatible with the observance of the regulations for new burial-grounds.

CHIPPING NORTON.—To be discontinued forthwith within the *church*, and also within the *mausoleum* attached thereto, unless all communication with the church be intercepted by an air-tight partition, and all coffins separately entombed in an air-tight manner, also (except in existing vaults and brick graves, in which each coffin shall be separately entombed in an air-tight manner,) in the old part of the *churchyard*; and that in the last consecrated part of the *churchyard*, and in the *Wesleyan* and *Baptist Chapel-yards*, the regulations for new burial-grounds shall be observed.

WITNEY, OXFORDSHIRE.—To be discontinued forthwith in the *Parish Church*, and (except in now existing walled graves, in which each coffin shall be separately entombed in an air-tight manner,) in the *churchyard* from and after the thirty-first of December, one thousand eight hundred and fifty-five.

GRANTHAM, LINCOLNSHIRE.—To be forthwith discontinued in the *Parish Church*, and in the *Roman Catholic Chapel* in the parish of Manthorpe cum Little Gonerby; and from and after the first of January, one thousand eight hundred and fifty-seven, in the *Parish Churchyard*, in the *Burial-ground, Grantham*, situated in the parish of Manthorpe cum Little Gonerby, and in the *Ebenezer Chapel Burial-ground* in the parish of *Spitlegate*.

LITTLE DEAN, GLOUCESTERSHIRE.—To be wholly discontinued in the *churchyard* and *church* on and after the thirty-first December, one thousand eight hundred and fifty-five; and that in the *Independent Burial-ground* the regulations for new burial-grounds be observed.

SWINDON, WILTS.—To be discontinued wholly within five yards of the churches, chapel or other building in the *Parish Churchyard, St. Mark's District Churchyard*, and the *Independent Chapelyard*; and that in the other parts of the *churchyards* the regulations for new burial-grounds be observed, and also in the burial-grounds of *Providence Chapel* and of the *Primitive Methodist Chapel*.

STOW-ON-THE-WOLD, GLOUCESTERSHIRE.—To be forthwith discontinued in the *Parish Church*, and also (except in now existing walled graves, in which each coffin shall be separately entombed with masonry in an air-tight manner,) in the *churchyard* on and after the thirty-first of December, one thousand eight hundred and fifty-five.

ROYSTON.—To be forthwith discontinued within five yards of all dwelling-houses in the *Parish Churchyard* of Royston, Herts and Cambridgeshire, in *Kneesworth Chapel Burial-ground*, and in the *Friends' Burial-ground* Royston, Cambridgeshire; and from and after the first of January, one thousand eight hundred and fifty-seven, wholly in the ancient portion of the *Parish Churchyard*, and in *Kneesworth Chapel*, Royston.

WHITWICK, LEICESTERSHIRE.—To be forthwith discontinued in the *Parish Church*, and in the *General Baptist Chapel Burial-ground* within five yards of the Chapel Day

School; and from and after the first of March, one thousand eight hundred and fifty-six, in the *Parish Churchyard*.

LOSTWITHIEL, CORNWALL.—To be forthwith discontinued beneath the *Parish Church*, and (except in existing vaults and brick graves, in which each coffin shall be separately entombed in an air-tight manner,) in the *churchyard* on and after the first of March, one thousand eight hundred and fifty-six.

BOWNESS, WESTMORLAND.—To be forthwith discontinued in the *church* and from and after the first of August, one thousand eight hundred and fifty-five, in the *churchyard*.

Now, therefore, Her Majesty in Council is pleased hereby to give notice of such representation, and to order that the same be taken into consideration by a Committee of the Lords of Her Majesty's Most Honourable Privy Council, on the fourteenth day of June next.

And Her Majesty is further pleased to direct that this Order be forthwith published in the London Gazette; and that copies thereof be affixed on the doors of the churches or chapels of, or on some conspicuous places within, the parishes affected by such representation, one month before the said fourteenth day of June.

The QUEEN's Most Excellent Majesty in Council.

WHEREAS the Right Honourable Sir George Grey, Baronet, one of Her Majesty's Principal Secretaries of State, after giving to the Incumbents and the Churchwardens of the parishes hereinafter mentioned ten days' previous notice of his intention to make such representation, has under the provisions of an Act, passed in the session of Parliament held in the sixteenth and seventeenth years of Her Majesty's reign, intitled "An Act to amend the laws concerning the burial of the dead in England beyond the limits of the metropolis, and to amend the Act concerning the burial of the dead in the metropolis," made a representation stating that, for the protection of the public health, no new burial-ground should be opened in any of the under-mentioned parishes, without the previous approval of one of Her Majesty's Principal Secretaries of State, and that burials should be discontinued therein, with the following modifications:

MITCHEL DEAN, GLOUCESTERSHIRE.—To be forthwith wholly discontinued in the *Church*, and in the *Churchyard*, except in that part which is north and west of the church, and in which the Regulations for New Burial-grounds shall be observed.

MILDENHALL, SUFFOLK.—To be forthwith discontinued in the *Church*, and in the *Churchyard* within four yards of all dwelling-houses, and from and after the first January, one thousand eight hundred and fifty-six, wholly in the above churchyard.

NEWLAND, GLOUCESTERSHIRE.—To be forthwith discontinued in the *Parish Church*, and the *Baptist Chapel* at *Coleford*; and also in *Newland Parish Churchyard*, and in the *Baptist* and *Independent Burial-grounds* at *Coleford*, in the same parish, except in ground which has never been opened and is free
