from water, and in family graves (for interment of members of the same family) which can be opened without the exposure of remains; no coffin to be placed less than four feet below the surface, and one only in a

CARISBROOKE, ISLE OF WIGHT .- To be forthwith discontinued in the Old Parish Church-yard, also in the Friends' Burial-ground within three yards of all dwelling-houses; also in the Burial-ground of the House of Industry within fifteen yards of the Infirmary; in the New Parish Burial-ground no burial to take place in any grave without a covering of earth four feet and a half in depth, measuring from the upper surface of the coffin to the level of the ground; and from and after the first June, one thousand eight hundred and fifty-eight, burials to be discontinued in the said New Parish Burial-ground, and in the Baptist Chapel Burial-ground.

NEWPORT, ISLE OF WIGHT.—To be forthwith discontinued in the old part of the Churchyard, and in the Roman Catholic Chapel, and from and after the first January, one thousand eight hundred and fifty-seven, in the Churchyard and in the Roman Catholic Chapel Burial-ground.

NORTHWOOD, ISLE OF WIGHT .-- To be forthwith discontinued in the old part of the Parish Churchyard and in the Parish Church, and from and after the first January, one thousand eight hundred and fifty-eight, in the new part of the Parish Churchyard.

WEST COWES, ISLE OF WIGHT .-- To be forthwith discontinued within West Cowes Church, and from and after the first May, one thousand eight hundred and fifty-six, in the Churchyard.

ARRETON, ISLE OF WIGHT.—To be discontinued forthwith under the Parish Church, and from and after the first March, one thousand eight hundred and fifty-six, in the Churchyard.

CARDIFF.-To be forthwith discontinued in the churches of St. John the Baptist and St. Mary, in the Ebenezer Chapel, in the Zion Chapel, in the Bethany Baptist Chapel, and in the Tabernacle; and (except in graves which can be opened to the depth of five feet without the exposure of remains, or in vaults or brick graves in which each coffin shall be separately entombed in an airtight manner, and except for the burial of the husbands, wives, parents, or unmarried children of those previously buried), in St. John's Churchyard, St. Mary's additional Churchyard, at the Cemetery, in Ebenezer and Zion Burialgrounds, and in the Tabernacle and Bethany Burial-grounds on and after the first April, one thousand eight hundred and fifty-six; and that in the additional Churchyard of St. John's parish, and in the Cemetery, the Regulations for New Burial-grounds be observed.

Now, therefore, Her Majesty in Council is pleased hereby to give notice of such representation, and to order that the same be taken into consideration by a Committee of the Lords of Her Majesty's Most Honourable Privy Council, on the fourteenth day of June next.

And Her Majesty is further pleased to direct that this Order be forthwith published in the London Gazette; and that copies thereof be affixed on the doors of the churches or chapels of,

or on some conspicuous places within, the parishes affected by such representation, one month before the said fourteenth day of June.

The QUEEN's Most Excellent Majesty in Council.

WHEREAS by an Act, passed in the last session of Parliament, intituled "An Act " to make further provision for the burial of the " dead in England beyond the limits of the metro-"polis," it is enacted that, in case it appear to Her Majesty in Council, upon the petition of the Town Council of any borough, stating that an Order in Council has been made for closing all or any of the burial-grounds of one or more parishes, being wholly or partly within such borough, that there is difficulty or inconvenience in providing, under the powers of an Act, passed in the session of Parliament held in the sixteenth and seven-teenth years of Her Majesty's reign, intituled "An Act to amend the laws concerning the "burial of the dead in England beyond the "limits of the metropolis, and to amend the Act "concerning the burial of the dead in the metro-"polis," requisite places of burial for the inhabitants of such parish or parishes, it shall be lawful for Her Majesty, with the advice of Her Privy Council, to order that powers shall be vested in the Council of such borough for providing such places of burial, under the provisions of this Act; provided always, that notice of such petition, and of the time when it shall please Her Majesty to order that the same be taken into consideration by the Privy Council, shall be published in the London Gazette, and in one of the newspapers usually circulating in such borough, one month at least before such petition is so considered;

And whereas the Town Council of the borough of King's Lynn have presented a petition to Her Majesty in Council, stating that an Order in Council has been issued for closing certain burialgrounds within the said borough, and that there is difficulty and inconvenience in providing, under the above-mentioned Act, passed in the sixteenth and seventeenth years of Her Majesty's reign, requisite places of burial for the inhabitants of the parishes of Saint Margaret and of South Lynn, otherwise All Saints, which constitute the said borough of King's Lynn, and praying that powers may be vested in the said Town Council for providing requisite places of burial for the inhabitants of the said parishes, under the above

first-recited Act;

And whereas notice of such petition, and of the time when Her Majesty was pleased to order that the same be taken into consideration by Her Privy Council, has been duly published as required

by the said above first-recited Act:

Now, therefore, Her Majesty is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, that powers be vested in the Town Council of the borough of King's Lynn for providing requisite places of burial for the inhabitants of the said parishes of Saint Margaret and of South Lynn, otherwise All Saints, which constitute the borough of King's Lynn, under the provisions of the said Act, passed in the last session of Parliament, intituled "An Act to make further provision for the burial "of the dead in England beyond the limits of the " metropolis."
