The Queen has been pleased to grant unto Henry Jones, of Cynghordy, in the parish of Llanfair ar y bryn, in the county of Carmarthen, Esquire, second and youngest son of Samuel Jones, late of Llanvillo, in the county of Brecon, Gentleman, by Jane his wife, daughter of William Vaughan, late of Penymaes, in the parish of Llanvillo aforesaid, Esquire, and sister of Thomas Vaughan, late of the town of Brecon, in the said county of Brecon, Clerk, all deceased, Her royal licence and authority that he and his issue may, in compliance with a condition and stipulation contained in the last will and testament of his maternal uncle, the said Reverend Thomas Vaughan, take and henceforth use the surnames of Gwynne-Vaughan only, and in lieu of that of Jones, and that he and they may take and bear the arms of Vaughan; such arms being first duly exemplified according to the laws of arms, and recorded in the Herald's Office, otherwise the said royal licence and authority to be void and of none effect:
