

Metropolitan Market Act, 1851.

NOTICE.

WHEREAS the Mayor, Aldermen, and Commons of the city of London did, within six calendar months after the passing of "The Metropolitan Market Act, 1851," signify under their common seal to the Right Honourable Spencer Horatio Walpole, then one of Her Majesty's Principal Secretaries of State, that they desired to undertake the execution of that Act, and have accordingly proceeded in the execution thereof, and have provided the market-places, slaughter-houses, and conveniences authorized by the said Act to be provided, and have fixed a table of tolls and payments, in the manner required by the said Act, and appointed the market days, and have done all other acts which appeared to them necessary previously to the opening of the said market-places and slaughter-houses, and have reported to me, the Right Honourable Sir George Grey, Baronet, one of Her Majesty's Principal Secretaries of State, what they have done concerning the premises, and have also annexed to their report a copy of the said table of tolls and payments: Now, I hereby fix Friday the 15th day of June, 1855, as the time for the opening of the said markets and slaughter-houses; and I do hereby notify, by this present notice under my hand, that such market-places and slaughter-houses have been provided, and that the same will be opened on Friday the 15th day of June, 1855, and that from that day Smithfield Market will cease to be a market for the sale of cattle and horses.

Provisional Orders.

Guildford and Farnham Road.

WHEREAS the Trustees of the Guildford and Farnham Turnpike Road, acting under the powers of the Local Act of the 3rd of George the Fourth, cap. 67, have made application to Her Majesty's Principal Secretary of State for the Home Department, pursuant to the Act of the session holden in the 14th and 15th years of the reign of Her present Majesty, cap. 38, for a Provisional Order, to reduce the rate of interest on the mortgage debt charged or secured on the tolls or revenues of the said road, and to extinguish the arrears of interest due upon the said debt;

And whereas the said application is dated the twelfth day of May, one thousand eight hundred and fifty-five, and is signed by three of the said trustees, who therein certify that the persons entitled to two-thirds of the money charged or secured on the tolls of the said road, and remaining unpaid, have signified their consents in writing under their hands to the said application;

And whereas it appears desirable to Her Majesty's Principal Secretary of State for the Home Department that the aforesaid application should be granted upon the terms herein set forth;

Now, therefore, in pursuance of the power and authority of the said Act of the 14th and 15th of Victoria, cap. 38, given to me as one of Her Majesty's Principal Secretaries of State, and in conformity with the said application, I do, by this Provisional Order, under my hand, declare, — subject to the confirmation hereof by Parliament, — that from the first day of January, one thousand eight hundred and fifty-five, the rate of interest shall be reduced from five pounds to

three pounds per centum, per annum, upon the bonded or mortgage debt of two thousand two hundred and fifteen pounds, charged or secured upon the tolls or revenues of the said road; and that the arrears of interest due and remaining unpaid upon the said debt at that date shall be extinguished.

Holmfirth District of Road.

WHEREAS the Trustees of the Holmfirth District Turnpike Road, acting under the powers of the Local Act of the session holden in the 7th and 8th years of the reign of Her present Majesty, cap. 72, have made application to Her Majesty's Principal Secretary of State for the Home Department, pursuant to the Act of the session holden in the 14th and 15th years of the reign of Her present Majesty, cap. 38, for a Provisional Order, to reduce the rate of interest on the mortgage debts, charged or secured on the tolls or revenues of the said district of road, and to extinguish the whole of the arrears of interest due upon the said debts;

And whereas the said application is dated the twenty-first day of May, one thousand eight hundred and fifty-five, and is signed by four of the said trustees, who therein certify that the persons entitled to two-thirds of the money charged or secured on the tolls of the said district of road, and remaining unpaid, have signified their consents in writing under their hands to the said application;

And whereas it appears desirable to Her Majesty's Principal Secretary of State for the Home Department, that the aforesaid application should be granted upon the terms herein set forth;

Now, therefore, in pursuance of the power and authority of the said Act of the 14th and 15th of Victoria, cap. 38, given to me as one of Her Majesty's Principal Secretaries of State, and in conformity with the said application, I do by this Provisional Order under my hand declare, — subject to the confirmation hereof by Parliament, — that, from the thirty-first day of December, one thousand eight hundred and fifty-four, the rate of interest shall be reduced from five pounds to two pounds per centum, per annum, upon the preference, bonded, or mortgage debt of one thousand five hundred pounds, and from five pounds to one penny per centum, per annum, upon the remaining bonded or mortgage debt of three thousand nine hundred and forty-four pounds, eighteen shillings, charged or secured upon the tolls or revenues of the said district of road; and that the whole of the arrears of interest due and remaining unpaid upon the said debts, at that date, shall be extinguished.
