The **QUEEN'S** Most Excellent Majesty in Council.

WHEREAS the Council of the borough of **HASTINGS** have, under the provisions of an Act, passed in the last session of Parliament, intituled "An Act to make further provision for the burial of the dead in England beyond the limits of the metropolis," presented a petition to Her Majesty in Council, stating that Orders in Council have been issued for closing burial-grounds in certain parishes within such borough, and praying that powers may be vested in the Council of the said borough for providing requisite places of burial for the inhabitants of the several entire parishes of All Saints, St. Clement, St. Andrew, the Holy Trinity, St. Michael, St. Mary Magdalen, and St. Mary Bulverhythe, and of the several parts of the parishes of St. Mary in the Castle, Ore, and St. Leonard, all situate within the borough of **HASTINGS** aforesaid, under the provisions of the said Act.

Now, therefore, Her Majesty in Council is pleased hereby to give notice of such petition, and to order that the same be taken into consideration by a Committee of the Lords of Her Majesty's Most Honourable Privy Council, on the sixteenth day of July next.

And Her Majesty is further pleased to direct that this Order be published in the *London Gazette*, and in one of the newspapers usually circulating in the said borough, one month at least before the said sixteenth day of July.
