#### NAVY BILLS.

NOTICE is hereby given, that the Commissioners for executing the Office of Lord High Admiral of the United Kingdom of Great Britain and Ireland, have established the following regulations relative to Naval Payments, and the mode of drawing Bills, which have been graciously approved by Her Majesty in Council, on the 26th June, 1855.

- 1.—Navy Bills issued for supplies of provisions, Victualling, Medical, and Naval Stores, Freight, and generally for all Contract Works, and Supplies, are to be made out payable at seven days after date.
- 2.—All Bills of Exchange drawn on the Accountant - General of the Navy, and accepted by him, payable in the Bill Account of the Paymaster-General at the Bank of England, are to be drawn at seven days after sight, instead of three days, as prescribed by Act 2nd, William IV., cap. 40, sec. 8.

These regulations are to come into operation on the 1st day of October next, without interfering with any contract or engagement in which the stipulation as to payment is not in accordance therewith.
