

'Parliament, for building and promoting the 'building of additional churches in populous 'parishes,' and in the third section of an Act of Parliament passed in the second and third years of your Majesty's reign, intituled 'An Act to 'make better provision for the assignment of 'ecclesiastical districts to churches or chapels 'augmented by the Governors of the Bounty of 'Queen Anne, and for other purposes,' and that such proposed district should be named 'THE 'DISTRICT CHAPELRY OF SAINT ALBAN ROCHE- 'DALE,' and that the boundaries thereof should be those hereinafter mentioned, that is to say :

"Commencing at Pinfold, at the centre of Drake-street and Pinfold-road, proceeding along the centre of Pinfold-road to the bridge over the River Roche, along the centre of the River Roche to the centre of Rochdale Bridge, and along the centre of Yorkshire-street, Lord-street, Toad-lane, St. Mary's-gate, and Bury-road, respectively, to the centre of the bridge over the River Spodden, and down the centre of the Rivers Spodden and Roche to where Sudden Brook joins the last-mentioned river, up the centre of Sudden Brook aforesaid to the centre of the bridge over the same upon the road leading from Castleton Hall to Hartley, following the centre of the same road toward Castleton Hall to the south-east side of the Lancashire and Yorkshire Railway, following that side of the same railway land to the centre of Stonyfield Bridge, and from thence along the centre of Boundary-street, Burrett-street, Grove-street, and Drake-street, to the point of commencement, as such district chapelry is more particularly delineated on the map or plan hereto annexed, and thereon coloured pink.

"Your Majesty's said Commissioners beg leave further to represent, that it also appears to them to be expedient that banns of marriage should be published, and that marriages, baptisms, and churchings should be solemnized or performed in Saint Alban's Church aforesaid ; and that the fees to arise therefrom should be paid and belong to the minister or incumbent of such church for the time being.

"That the consent of the Right Reverend James Prince, Bishop of the said diocese of Manchester, has been obtained thereto, as required by the Acts and sections hereinbefore mentioned, in testimony whereof he has signed and sealed this representation.

"Your Majesty's said Commissioners therefore humbly pray that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such Order in respect thereto as to your Majesty in your royal wisdom shall seem meet."

Her Majesty having taken the said representation, together with the map or plan thereunto annexed into consideration, was pleased by and with the advice of Her Privy Council to order, and it is hereby ordered, that the proposed assignment of a district chapelry to the consecrated church of SAINT ALBAN, in the parish of ROCHE-DALE, be accordingly made, and that the recommendations of the said Commissioners in respect of the publication of banns and the solemnization of marriages, baptisms, and churchings, and in respect of the fees to arise therefrom, be carried into effect agreeably to the provisions of the said Acts ; and Her Majesty was further pleased to direct that this Order be forthwith registered by the Registrar of the diocese of Manchester.

WHEREAS Her Majesty's Commissioners for building new churches, in pursuance of the sixteenth section of an Act of Parliament, passed in the fifty-ninth year of the reign of His Majesty King George the Third, intituled "An Act to amend and render more effectual an Act, "passed in the last session of Parliament, for "building and promoting the building of additional "churches in populous parishes," and of the third section of an Act, passed in the session of Parliament held in the second and third years of Her Majesty's reign, intituled "An Act to make better "provision for the assignment of ecclesiastical "districts to churches or chapels augmented by "the Governors of the Bounty of Queen Anne, "and for other purposes," have, duly prepared and laid before Her Majesty in Council a representation, bearing date the twenty-fifth day of April, one thousand eight hundred and fifty-six, in the words following ; viz :

"Your Majesty's Commissioners for building new churches beg humbly to represent that having taken into consideration all the circumstances of the parish of Plymstock, in the county of Devon, and in the diocese of Exeter, it appears to them to be expedient that a particular district should be assigned to the consecrated church of Saint John, situate at Hooe, in the said parish of Plymstock, under and by virtue of the power or authority contained in the sixteenth section of an Act of Parliament, passed in the fifty-ninth year of the reign of His Majesty King George the Third, intituled 'An Act to amend and render 'more effectual an Act, passed in the last session 'of Parliament, for building and promoting the 'building of additional churches in populous 'parishes,' and in the third section of an Act of Parliament, passed in the second and third years of your Majesty's reign, intituled 'An Act to 'make better provision for the assignment of 'ecclesiastical districts to churches or chapels augmented by the Governors of the Bounty of 'Queen Anne, and for other purposes,' and that such proposed district should be named 'THE 'DISTRICT CHAPELRY OF HOOE,' and that the boundaries thereof should be those hereinafter mentioned ; that is to say :

"The District Chapelry of Hooe is to consist of the westernmost portion of the parish of Plymstock, and is bounded on the east by a line proceeding from the water in a southerly direction along the line of fence separating the property of Colonel Harris, from the property of Mr. J. Hart, until such fence reaches the road leading from Hooe to Plymstock, and then proceeds north-westerly along the southern side of the road, until it reaches the road leading from Hooe to Staddiscombe, and then proceeds in a southerly direction along the eastern side of that road, until it reaches the road which leads to Bovisand, and proceeds southerly along the eastern side of that road, and then westerly along the southern side of the road as far as the point where it meets the boundary line of the parishes of Plymstock and Wembury, along which the said boundary line of the said District Chapelry of Hooe proceeds westerly, until it reaches the sea, by which it is bounded on the east, north and north-east as far as the point where the boundary line commenced, as such District Chapelry of Hooe is more particularly delineated on
