

the county of Dorset, and such shipping therein, and such Government Establishments there and near thereto, and such other persons as the said Commissioners may deem expedient, and for that purpose to effect the objects following, or some of them; that is to say:

To purchase compulsorily or by agreement, acquire and appropriate certain lands, and the Undercliff, beach, and sea shore near thereto, situate in the parish of Portland, in the county of Dorset, at or near Under Weech Chine or Chene, near to the village of Southwell, and also the Tank thereon, and the waters thereof, and the existing pumps, engines, and works in connection therewith, and the springs, streams, and waters flowing over, under, or out of those lands, Undercliff, beach, and seashore, or arising therefrom, and the reservoirs, pipes, and conduits now constructed and laid down for conducting and storing water to and near to, and for the said harbour (which pipes or conduits commence at or in the said Tank, and terminate in a reservoir near to the village of Castletown, all in the said parish of Portland), and to maintain, repair, extend, enlarge, renew, or remove the said Tank, pumps, engines, pipes, conduits, and works:

To make and maintain shafts, wells, pumping apparatus, and also a conduit or main line of pipes commencing from and out of the said existing line of pipes in that portion of the said lands, which is called Netherfield, between Southwell aforesaid and Pennsylvania Castle, and terminating by a junction with the said existing line of pipes at a point in the parish road leading from Southwell to Wakeham, adjoining a field called Duns Croft, otherwise Duns Croft: And also another conduit or main line of pipes commencing from and out of the said existing line of pipes at a point in the said parish road, about seventy yards to the northward of the northern end of Duns Croft, otherwise Duns Croft aforesaid, and terminating by a junction with the said existing line of pipes in lands belonging to the said Commissioners at a point about 230 yards to the north-east of the Clifton Hotel, in the said parish, together with all necessary or convenient embankments, filtering-beds, drains, wells, tanks, reservoirs, engines, and other works in connection with the existing and proposed works, and for collecting, storing up, and using the waters of the springs and streams aforesaid, and any other springs and streams in the line of the said works, and to purchase by compulsion or agreement any lands and hereditaments, or any interests in lands or hereditaments requisite for the purposes of the undertaking; which said existing pipes, conduits, reservoirs, and works are, and which said intended conduits, pipes, tanks, and works will be situate wholly within the said parish of Portland, in the county of Dorset:

To lay down, construct, and maintain within the said parish, or any part thereof, pipes and other works, for the distribution of water, and for the purposes aforesaid, to cross, break up, alter, divert, or stop up, either temporarily or permanently, any roads, highways, footpaths, streets, bridges, tramways, sewers, and drains therein:

To remove or abandon any part of the existing pipes, conduits, and works, which may be rendered unnecessary by the construction of the intended new conduits, pipes, and works:

To divert into the existing and intended conduits or lines of pipes, tanks, reservoirs, and works the waters now supplying the said existing pipes, tanks, reservoirs, and works, and the waters of the Tank springs and streams aforesaid:

To recover and receive rates and charges for the proposed supply of water, to confer exemptions

from the payment thereof, and to confer, vary, or extinguish other rights and privileges.

And it is also intended by the said Act to amend the Public Act of 10 and 11 Victoria, chapter 24, relating to the purchase of lands for the said harbour, to vary or extinguish any rights or privileges connected with the springs, streams, waters, lands, works, and hereditaments, to be purchased or taken under the said proposed Act, and any other rights or privileges which would interfere with the objects thereof, and to make provision for ascertaining the persons entitled to any interest in the said springs, streams, waters, lands, works, and hereditaments, and for effecting a conveyance thereof, and for the appropriation of the purchase money or compensation payable in respect thereof, and (if need be) for the appointment, by the inhabitants or others, of committees or other bodies and officers for those purposes, and so far as may be necessary or expedient to incorporate the provisions of "The Waterworks Clauses Act, 1847," with the said proposed Act.

And it is also intended by the said proposed Act to vest in the said Commissioners, in trust, for Her Majesty, her heirs, and successors certain lands and hereditaments in the said parish, now vested in or belonging to Her Majesty, but which have been appropriated for the purposes of the said harbour, together with the site of the said harbour, and of its breakwaters, and other works, and to enable the said Commissioners to sell, exchange, and otherwise dispose of, demise, and let all or any part of the hereditaments to be acquired by and vested in them under the said proposed Act.

And notice is hereby given that, on or before the 29th day of November, 1856, duplicate plans and sections of the works intended to be taken, and of the proposed new works, with a book of reference to such plans, containing the names of the owners or reputed owners, lessees or reputed lessees, and occupiers of all lands intended to be taken, and a copy of this notice as published in the London Gazette, will be deposited for public inspection at the office of the Clerk of the Peace for the county of Dorset, at Sherborne, in that county; and that, on or before the said 29th day of November, a copy of the said plans, sections, and book of reference, and a copy of this notice as published in the London Gazette, will be deposited for public inspection with the parish clerk of the said parish of Portland, at his residence.
