horses, cattle, and vehicles of all kinds whatsoever, as well as for foot passengers; and also to use and authorize the use of the said piers by steamboats and other vessels, for the landing and embarking of passengers and goods to or from the same.

To purchase and take lands, houses, and other hereditaments compulsorily and by agreement, for all or any of the purposes of the said Bill, and to vary or extinguish all existing rights or privileges in any manner connected with such lands, houses, or hereditaments, or which would interfere with the construction, maintenance, or use of the said bridge, piers, approaches, and works.

To make lateral deviations from the lines of the said proposed works to the extent or within the limits defined upon the plans hereinafter men-
