3rd.—To confirm the existing preference stock and shares of the said Company, to enable the Company to raise further capital for the general purposes of the Company, by mortgage and by the creation of new shares, with or without a preferential dividend or other special advantages:

4th.—For carrying into effect all or any of the above objects, and for other purposes, so far as may be necessary therefor, but not further or otherwise, to alter, amend, extend, and enlarge, and if need be to repeal all or any of the powers and provisions of the first-mentioned Act (16 and 17 Vict., chap. 134), and of the other Acts relating to the said Company.
