The QUEEN's Most Excellent Majesty in Council.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the fifth and sixth years of Her Majesty, chapter twenty-six, sections one, two, and eleven, duly prepared and laid before Her Majesty in Council a scheme, bearing date the eleventh day of December, in the year one thousand eight hundred and fifty-six, in the words following; that is to say:

England, in pursuance of the Act of the fifth and sixth years of your Majesty; chapter twenty-six, sections one, two and eleven, have prepared and now humbly lay before your Majesty in Council the following scheme for relieving the Bishops of Gloucester and Bristol from one of the houses of residence belonging to the see, and for authorising the repair, alteration, and improvement of the other of such houses.

"Whereas there are two houses of residence belonging to the see of Gloucester and Bristol, the one situate at Stapleton, near the city of Bristol, and the other in the city of Gloucester.

"And whereas, having regard to the position of the city of Gloucester in relation to the other parts of the diocese, and to the convenience of access thereto for the clergy and other inhabitants of the same diocese, we deem it expedient that the said last mentioned house should be the sole episcopal house of residence of the Bishop of Gloucester and Bristol for the time being, and that such bishop should be relieved from the other of the said houses.

"And whereas the said house of residence at Gloucester requires additions, alterations, and improvements to be made therein, in order to render it a suitable and convenient episcopal residence.

"Now, therefore, with the consent of the Right Reverend Charles, Bishop of Gloucester and Bristol, testified by his having signed this scheme and affixed thereto his episcopal seal, we humbly recommend and propose that the said bishop or his successors may be authorised and empowered to sell and duly to convey the said house and premises, situate at Stapleton, and all the estate, right, title and interest of him the said bishop and his

successors, bishops of Gloucester and Bristol, in and to the same, together with certain lands attached thereto, containing by estimation fifty-three acres and three roods, with a water corn-mill and premises, be the same quantity little more or less, and every part thereof, unto and to the use of such person or body corporate, and for such consideration as may be recommended in a scheme prepared by us and ratified by an Order of your Majesty in Council:

"And we further recommend and propose, that

"And we further recommend and propose, that every sum of money being or forming part of such consideration, shall be paid into the Bank of England to our credit to an account intituled Account with the Ecclesiastical Commissioners for England,' and that it shall not be incumbent on the purchaser taking such conveyance as aforesaid, after payment of the purchase-money to our credit as aforesaid, to see to the due application of such money:

"And we further recommend and propose, that out of the proceeds of such sale as aforesaid, there shall be paid by us, at such times and in such manner as we shall deem expedient, such sum or sums as shall be necessary for effecting such additions, alterations, and improvements in the said house of residence at Gloucester as shall, in our opinion, be necessary for rendering it a suitable and convenient residence for the Bishop of the said see of Gloucester and Bristol:

" And we further recommend and propose, that so soon as such alterations and improvements shall have been completed as aforesaid, the Bishop of Gloucester and Bristol for the time being shall, at his personal charge and expense, insure and keep insured the said episcopal house of residence from loss or damage by fire in one of the public offices of assurance in London or Westminster, to be approved by us, in the sum of ten thousand pounds, and that such bishop shall, within fourteen days after any premium for such insurance shall have become due, deliver to us the receipt for the same, and that in the case of any loss or damage by fire to the said house any and every sum of money receivable under such insurance shall become and be payable, and be paid to and deposited with us, in trust, to be applied, and the same, together with any interest and accumulations thereof, shall be applied by us towards the rebuilding or repairing and the reinstating of the said house, or of any part thereof which may have so suffered loss or damage, in such manner as shall be determined on by us with the concurrence of the Bishop of Gloucester and Bristol for the time being:

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in conformity with the provisions of the hereinnamed Act, or of any other Act of Parliament."

And whereas the said scheme has been approved by Her Majesty in Council, now therefore Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the respective Registrars of the two several registries of the diocese of Gloucester and Bristol at Bristol and Gloucester.

WHEREAS Her Majesty's Commissioners for building new churches, in pursuance of the sixth section of an Act passed in the session of Parliament, holden in the third and fourth years of Her Majesty's reign, intituled "An Act to "further amend the Church Building Acts," and of the sixteenth section of an Act passed in the session of Parliament, holden in the eighth and ninth years of Her Majesty's reign, intituled "An "Act for the further amendment of the Church "Building Acts," have duly prepared and laid before Her Majesty in Council a representation, bearing date the twenty-second day of December, one thousand eight hundred and fifty-six, in the words following, viz.:

"Your Majesty's Commissioners for building new churches, beg leave humbly to represent that on or about the twenty-seventh day of May, one thousand eight hundred and fifty-two, your Majesty's said Commissioners made a representation to your Majesty in Council, that it appeared to them to be expedient, and they therefore humbly prayed, that the boundaries of the district chapelry called Saint John's District, which was assigned to Saint John's Church, in the parish of Richmond, in the county of Surrey, and diocese of Winchester, by an Order of your Majesty in Council, bearing date the twenty-ninth day of November, one thousand eight hundred and thirty-eight, and in conformity with the provisions of the sixteenth section of an Act passed in the fifty-ninth year of the reign of His Majesty King George the Third, intituled 'An Act to amend and render more effectual an Act passed in the last session of Parliament, for building and promoting the building of additional churches in 'populous parishes,' should be altered, under or by virtue of the powers or authorities for such purpose, contained in the sixth section of an Act passed in the session of Parliament holden in the third and fourth years of your Majesty's reign, intituled 'An Act to further amend the Church Building Acts,' and the sixteenth section of an Act passed in the session of Parliament holden in the eighth and ninth years of your Majesty's reign, intituled 'An Act for the further amend-

'ment of the Church Building Acts,' and that in lieu of the boundaries set forth in such last-mentioned Order of your Majesty in Council, the boundaries described in the said representation, and next hereinafter mentioned, should be substituted for those comprised in the said Order in Council of the twenty-ninth day of November, one thousand eight hundred and thirty-eight; that is to say: the boundary line of Saint John's District, to commence on the west side of the high road leading from Richmond-hill, on the east side of Home Castle, to a boundary line of Richmond Parish North, so as to include the conduit, and also that part of the ground in Richmond parish, which is occupied by William Frederick Gostling, Esq., north-east along the boundary line separating the parishes of Richmond and Mortlake, as far as Sandy-lane, then westward down Sandy-lane, into Kew-road, south-west along the middle of Kew-road, to the boundary fence separating the Royal Gardens from part of the Old Deer Park, then running westerly along such fence for about three hundred yards, then running south-westerly to the corner of the wall of the footpath, and continuing along such boundary wall until it reaches the bridge over the line of the Windsor, Staines, and South-Western Railway, near the north corner of Richmond-green, and entrance into the Old Deer Park, then easterly along the north side of the line of that railway, up to the railway bridge in Park Shot-road, formerly called Kewfoot-lane, and passing thence south-westerly along the road, to the corner of Duke-street, then up that street, eastwardly along the south side of the late Mechanics' Institution (formerly the site of the Old Town Pond), and along the middle of the road leading from Richmond to Marsh Gate, as far as Spring-terrace, south-west to the end of Spring-terrace, and the corner of a road, formerly a Worple-way, leading to Mount Ararat, then southerly along that road to Friars Stile, then south-easterly along the north-east side of the footway through a field leading to Home Castle, to the point where the boundary commences, as the same was more particularly delineated on the plan annexed to the said representation, and thereon coloured pink.

"That by an Order of your Majesty in Council, bearing date the fifteenth day of June, one thousand eight hundred and fifty-two, your Majesty was pleased by and with the advice of your Privy Council, to approve of the said representation, and to order that the recommendations of the said Commissioners in respect of the boundaries of the said district, be carried into effect agreeably to the provisions of the said Acts, and was further pleased to direct that such order should be forthwith registered by the Registrar of the said

diocese of Winchester

"Your Majesty's said Commissioners beg leave further to represent that having taken into consideration the present circumstances of the said parish of Richmond, and also of the said district so assigned to the said church of Saint John, and since altered as aforesaid, it appears to them to be expedient that the boundaries of such district should be again altered under or by virtue of the said powers or authorities contained in the Acts so passed in the third and fourth, and in the eighth and ninth years of your Majesty's reign as aforesaid, and that the boundaries next hereinafter set forth, should be substituted for those comprised in the said Order of your Majesty in Council, of the fifteenth day of June, one thousand eight hundred and fifty-two; that is to say: the boundary line of Saint John's District, to commence on the west side of the high road leading from Richmond-hill,

now called Queen's-road, on the east side of the site where Holme Castle formerly stood, to a boundary line of Richmond parish north, so as to include the conduit, and also that part of the ground in Richmond parish, which was lately occupied by William Frederick Gostling, Esq., north-east along the boundary line separating the parishes of Richmond and Mortlake, as far as Sandy-lane, then westward down Sandy-lane, into Kew-road, south-west along the middle of Kewroad, to the boundary fence separating the Royal Gardens from part of the Old Deer Park, then running westerly along such fence for about three hundred yards, then running south-west to the corner of the wall of the footpath, and continuing along such boundary wall until it reaches the bridge over the line of the Windsor, Staines, and South-Western Railway, near the north corner of Richmond Green, and entrance into the Old Deer Park, then easterly along the north side of the line of that railway up to the railway bridge in Park Shot-road, formerly called Kewfoot-lane, and passing thence south-westerly along the road to the corner of Duke-street, then up that street eastwardly, along the south side of the building lately the Mechanics' Institution, now converted into, and used as public baths and wash-houses (formerly the site of the Old Town Pond), and along the middle of the road leading from Richmond to Marsh Gate, as far as Spring-terrace, south-west to the end of Spring-terrace, and the corner of a road, formerly a worple-way, leading to Mount Ararat, then southerly along that road up to a distance of sixty yards from Friars Stile-road, then north-easterly along a field belonging to Charles Jasper Selwyn, Esq., for about one hundred and thirty yards up to a footway leading from the old worple-way, near Marsh Gate, to Friars Stile-road, through a field lately belonging to George Robinson, deceased, at the north-east end of Friars Stile-road, then south-westerly along that footway and road, up to Friars Stile, then south-easterly along the north-east side of a road (formerly a footway), lately made through a field leading to the site where Home Castle formerly stood, to the point where the boundary commences, as the same is more particularly described in the plan hereunto annexed, and thereon coloured pink.

"That the consents of the Right Reverend Charles Richard, Bishop of the said diocese of Winchester, of the Provost and Fellows of King's College within the University of Cambridge (patrons of the parish church of the said parish of Richmond), and of the Reverend Harry Dupuis, Bachelor of Divinity (Vicar and Incumbent of the said parish church), have been severally obtained to such proposed alteration of boundaries as aforesaid, as required by the two Acts and sections lastly hereinbefore mentioned; in testimony whereof the said Charles Richard, Bishop of Winchester, has hereto set his hand and seal the twenty-ninth day of April, one thousand eight hundred and fifty-six; the said Harry Dupuis has also hereto set his hand and seal the first day of May in the same year; and the said Provost and Fellows have, on the tenth day of December in the same year, hereto affixed their common or

college seal.

"Your Majesty's said Commissioners therefore humby pray, that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such Order in respect thereto as to your Majesty in your royal wisdom shall seem meet."

Her Majesty, having taken the said representa-A 2

tion, together with the plan thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, and it is hereby ordered, that the recommendations of the said Commissioners in respect of the further alteration of the boundaries of the district chapelry, called Saint John's District (which was assigned to Saint John's Church, in the parish of Richmond, in the county of Surrey, by an Order of Her Majesty in Council, bearing date the twenty-ninth day of November, one thousand eight hundred and thirty-eight, and the boundaries of which district chapelry were altered by another Order of Her Majesty in Council, bearing date the lifteenth day of June, one thousand eight hundred and fifty-two), be carried into effect agreeably to the provisions of the said Acts; and Her Majesty is further pleased to direct that this Order be forthwith registered by the Registrar of the diocese of Winchester.

To the Clerk or Clerks to the Justices of the Petty Sessions held for the division or divisions in which the said parish is situate;—And to all others whom it may concern.

WHEREAS the population of the parish of Bromley Saint Leonard, in the county of Middlesex, according to the last census, exceeds two thousand persons:

And whereas at a meeting of the Vestry of the said parish, held in the Vestry Clerk's Office, after public notice in that behalf, on Thursday the twentieth day of November, one thousand eight hundred and fifty-six, it was resolved,—

"That the Poor Law Board be requested to "isssue an Order under their Seal of Office, "directing that the Act passed on the 5th "August, 1850 (13 and 14 Vict., c. 57), "entitled 'An Act to prevent the holding of "vestry or other meetings in churches, and for regulating the appointment of Vestry "Clerks,' shall be applied to and put in "force in this parish, as regards the appointment of a Vestry Clerk."

And whereas the Churchwardens of the said parish have made their application in writing to the Poor Law Board, pursuant to the above resolution.

Now, therefore, we, the Poor Law Board, under the authority of the several Statutes in that behalf made and provided, do hereby order and direct as follows; that is to say:

ARTICLE 1.—That so much of the said Act passed in the fourteenth year of the reign of Her Majesty as relates to the appointment of a Vestry Clerk shall forthwith be applied to, and be put in force within, the said parish of Bromley Saint Leonard.

ARTICLE 2.—That a salary of three hundred pounds a year shall be paid to the Vestry Clerk for the time being, appointed under the authority of the Statutes in such behalf and this Order, by the Churchwardens and Overseers of the Poor of the said parish.

ARTICLE 3.—That the salary of such Vestry Clerk shall be payable up to the day on which he ceases to hold such office, and no longer, and shall be paid by quarterly payments at the several quarters ending at the usual Feast days in the year, namely, Lady Day, Midsummer Day, Michaelmas Day, and Christmas Day, with a porportionate sum to be paid to his executors or administrators, in case he shall die while holding such office.

And, at the request of the said Churchwardens, we do hereby prescribe and direct, that the said Vestry Clerk shall perform the following duties, in addition to those set forth in the said Act:—

To act as clerk to the trustees under the Local Act of the said parish, issue notices of and attend meetings of the said trustees, and keep the minutes of the trustees, and conduct all correspondence arising therefrom, and perform such other duties as may be required by the said Act.

To take the examination of all paupers chargeable to the said parish relative to their legal settlement, and make the necessary inquiries therein.

To prepare all documents necessary to obtain orders of removal, and adopt all such subsequent proceedings as the law may require for the removal of paupers, which he shall be legally qualified to perform.

To investigate the merits of all orders of removal from other parishes, when required.

That a copy of this Order shall be published in the London Gazette.
