THEREAS the population of the parish of Winkfield, in the county of Berks, according to the last census, exceeds two thousand persons.

And whereas at a meeting of the General Vestry of the Parish held at the Vestry Room, after public notice in that behalf, on Tuesday the sixteenth day of September, one thousand eight hundred and fifty-six, it was resolved,-

"That the Churchwardens apply to the Poor "Law Board to enforce in this parish so much of the Act 13th and 14th Vic., c. 57, " as relates to the appointment of a Vestry

within, the said parish of Winkfield.

[ARTICLE 2.—That a salary of twenty pounds a year shall be paid to the Vestry Clerk for the time being, appointed under the authority of the Statutes in such behalf and this Order, by the Churchwardens and Overseers of the Poor of the said parish.
