quarters ending at the usual Feast days in the year, namely, Lady Day, Midsummer Day, Michaelmas Day, and Christmas Day, with a proportionate sum to be paid to his executors or administrators, in case he shall die while holding such office.

And, at the request of the said Churchwardens, we do hereby prescribe and direct, that the said Vestry Clerk shall perform the following duties, in addition to those set forth in the said Act:-

To conduct all correspondence relative to the affairs of the said parish when so required.

To conduct all cases of removal and appeal, so far as can be done by a person not being an Attorney.

To make out all rate books, and receipt check books, when so requested, assisted by the collectors of the respective rates.
