next following, the said District Chapelry was duly assigned out of the parish of Clifton, in the same

county and diocese.

"And whereas it has been made to appear to us to be expedient, that the boundaries of such District Chapelry should be altered so as to include within them a further portion of the said parish of Clifton, and also a portion of the adjacent parish of Saint George, Brandon Hill, in the same county and diocese, as hereinafter mentioned.

"Now, therefore, with the consent of the Right Reverend Charles, Bishop of Gloucester and Bristol, and the Reverend William Marsh, of Beckenham, in the county of Kent, Doctor in Divinity, the Reverend William Carus, of the city of Winchester, Clerk, the Reverend John Venn, of the city of Hereford, Clerk, the Reverend Edmund Hollond, of Hyde Park Gardens, in the county of Middlesex and of Benhall Lodge, in the county of Suffolk, Clerk, and the Reverend Edward Auriol, of Mecklenburgh-square, in the said county of Middlesex, patrons of the parish church of the said parish of Clifton, and also of the said church of Saint Peter, Clifton Wood, the Reverend John Hensman, incumbent of the same parish church, and the Reverend James Ezekiel Nash, incumbent of the said District Chapelry of Saint Peter, Clifton Wood, in testimony whereof they have re-spectively signed and sealed this representation, and also with the consent of the Dean and Chapter of the cathedral church of Bristol, patrons of the parish church of the said parish of Saint George, Brandon Hill, and the Reverend Ralph Lambton Hopper, incumbent of such last-named parish church, in testimony whereof the said dean and chapter have hereunto affixed their common seal, and the said Ralph Lambton Hopper hath hereunto set his hand and seal, we beg leave to represent that it appears to us to be expedient that the boundaries of the said District Chapelry of Saint Peter, Clifton Wood, should be altered so as to include therein all that portion of the parish of Clifton, in the county of Gloucester, and in the diocese of Gloucester and Bristol, which is bounded on the west, north, and east, by an imaginary line commencing on the northern boundary of the said District Chapelry of Saint Peter, Clifton Wood, at a point opposite to the middle of the southern end of a road or street, called Bell Vue, and extending thence in a northerly direction along the middle of such last-mentioned road or street, to the middle of a road called Clifton Hill, and extending thence in an easterly direction along the middle of such last-mentioned road, to a point opposite to the middle of a lane, called Goose Lane, and extending thence in a southeasternly and southernly direction along the middle of such last-mentioned lane to the boundary between the said parish of Clifton and the parish of Saint George, Brandon Hill; and also all that part of the said parish of Saint George, Brandon Hill, which is situate to the south and west of an imaginary line, commencing at a point on the lastmentioned boundary of such parish, in the middle of Woodwell Lane, opposite to the northern boundary of the house No. 35, in Woodwell Crescent, and extending thence first eastward and then southward and eastward along the middle of such boundary, and of the rear boundaries of the houses and premises in such crescent numbered from 35 to 8, both inclusive, across the lane called Lime Kiln Lane, in a direct line south-ward to the middle of Gas House Lane, at its northern extremity, and extending thence along the middle of such last-mentioned lane to the boundary of the said parish of Saint George, Brandon Hill; all which portions are delineated on the map hereunto annexed.

"And we humbly pray that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such Order in respect thereto as to your Majesty, in your Royal wisdom, shall seem meet."

Her Majesty, having taken the said representation, together with the map or plan thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, and it is hereby ordered, that the recommendations of the said Commissioners, with reference to the alteration of the boundaries of the said District Chapelry of Saint Peter, Clifton Wood, be carried into effect, agreeably to the provisions of the said Acts; and Her Majesty is further pleased to direct that this Order be forthwith registered by the respective Registrars of the two several registries of the diocese of Gloucester and Bristol, at Gloucester and at Bristol,
