John Martin, of Lincoln's-inn, in the same county, Gentleman, patrons of the parish church of the said parish of Saint Mary, Islington; and the Reverend Daniel Wilson, Incumbent of the same church; in testimony whereof they have respectively signed and sealed this representation, we beg leave to represent that it appears to us to be expedient that the boundaries of the said District Chapelry, called Saint Peter's District, should be altered so as to include therein all that part of the parish of Saint Mary, Islington, in the county of Middlesex, and diocese of London which is at present comprised within the Ecclesiastical District attached to the mother church of Saint Mary, and which is situate to the south of an imaginary line extending along the middle of the street known as the Lower-road, and to the east of an imaginary line extending along the middle of Queen's Head-lane, across Frog-lane, and along the middle of Dame-street; all which part is delineated on the map hereunto annexed.

"And we humbly pray that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such Order in respect thereto as to your Majesty in your Royal wisdom shall seem meet."

Her Majesty having taken the said representation, together with the map or plan thereunto annexed into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, and it is hereby ordered, that the recommendations of the said Commissioners with reference to the alteration in the boundaries of the said District Chapelry, called Saint Peter's District, be carried into effect, agreeably to the provisions of the said Acts; and Her Majesty is further pleased to direct that this Order be forthwith registered by the Registrar of the diocese of London.

The QUEEN's Most Excellent Majesty in Council.

WHEREAS there was this day read at the Board a Report from the General Board of Health, dated the twenty-second day of March, one thousand eight hundred and fifty-eight, in the words following; that is to say:

" To the Queen's Most Excellent Majesty.

"The General Board of Health, appointed for the purposes of 'The Public Health Act, 1848,' have, in pursuance of the provisions of that Act, upon the petition of not less than one-tenth of the inhabitants rated to the relief of the poor of and within the hamlet of Brentwood, in the parish of South Weald, in the county of Essex (the number of the said petitioners exceeding thirty in the whole), directed Alfred Lamerte Dickens, a Superintending Inspector appointed for purposes of the said Public Health Act, to visit the said hamlet, and to make inquiry, and to examine witnesses as to the sewerage, drainage, and supply of water, the state of the burial-grounds, the number and sanitary condition of the inhabitants, and as to any local Acts of Parliament in force within such hamlet for paving, lighting, cleansing, watching, regulating, supplying with water, or improving the said hamlet, or having relation to the purposes of the said Public Health Act; also as to the natural drainage areas, and the existing municipal, parochial, and other local boundaries, and the boundaries which might be most advantageously adopted for the purposes of that Act:

"And the said Superintending Inspector having previously given the notices directed by the said Public Health Act, proceeded upon the said enquiry in the manner directed by that Act, and hath reported in writing to the said Board upon the said several matters with respect to which he was directed to enquire, and upon certain other matters with respect to which he deemed it expedient to report for the purposes of that Act;

"And copies of the said report, accompanied by a notice stating that written statements might be forwarded to the said Board with respect to any matter contained in, or omitted from, the said report, or any amendment proposed to be made therein, have been duly published and deposited, as directed by the said Public Health Act, and the time for forwarding such statements has now elapsed, and the statement which has been received by the said Board has been duly deposited as required by that Act:

"And it appears by the said Report that there is no local Act of Parliament in force within the said hamlet for paving, lighting (otherwise than for the profit of proprietors or shareholders), cleansing, watching, regulating, supplying with water, or improving such hamlet, or any part thereof, or in anywise relating to the purposes of

the said Public Health Act;

" Now, therefore, the General Board of Health do hereby, under my hand, as President of the said Board, and under its seal of office, and in pursuance of the said Public Health Act, humbly report to your Majesty that it appears to us to be expedient that:

"1. 'The Public Health Act, 1848,' and every part thereof, except the section numbered 50 in the copies of that Act printed by your Majesty's Printers, should be applied to, and be in force within and throughout the entire area, places, and parts of places comprised within the boundaries of the said hamlet of Brentwood, in the parish of South Weald, in the county of Essex, and that such area, places, and parts of places should be and constitute a district for the purposes of the said Public Health Act accordingly.

"2. The Local Board of Health to be elected under the said Public Health Act should consist of twelve persons, and that the entire number should be elected for the whole of the said district.

"3. The first election of the said Local Board should take place on the fifteenth day of April, in the year of our Lord one thousand eight hundred

and fifty-eight.

"4. One-third in number of the said Local Board of Health should go out of office on the twenty-fifth day of September in each year subsequently to that in which the said first election of that Local Board takes place; but in case the day so appointed should fall on a Sunday, or on a day appointed for public fast or thanksgiving, then that such one-third should go out of office on the day ne t following.

" 5. Every person at the time of his election as member of the said Local Board, and so long as he shall continue in office by virtue of such election, should be resident as in the said 'Public Health Act, 1848,' is required, and be seized or possessed of real or personal estate, or both, to the value or amount of not less than eight hundred pounds, or should be so resident, and rated to the relief of the poor of some parish, township, or
