(Amendment of Acts; Alteration of Stourbridge Branch; Abandonment of parts of Stourbridge and Kingswinford Branches, and of Diglis Branch; Extension of Time for completing Stratford-upon-Avon Branch; Arrangements as to Rent-Charges on Stratford-upon-Avon Canal; and as to Arrears on Second Guaranteed Stock.)

NOTICE is hereby given, that powers will be sought in a Bill now pending in Parliament, intituled "A Bill to confer further Powers upon the Oxford, Worcester, and Wolverhampton Railway Company, with respect to the Completion, Alteration, or Abandonment of certain of their Branch Railways, and to authorise certain arrangements with respect to their Share-Capital and the Purchase of the Stratford-upon-Avon Canal, and to Amend the Acts relating to the Company, and for other purposes," to make and maintain a Siding with all proper works and conveniences connected therewith, as hereinafter described, in lieu of the Diglis Branch sought to be abandoned by such Bill, that is to say: a Siding commencing by a junction with the Worcester and Hereford Railway at or near a point on such railway 55 yards or thereabouts from the western side of Foregate-street, in the parish of St. Nicholas, and terminating on the eastern side of the river Severn, in or near a certain field in the occupation of Charles Wilson, in the parish of Claines, with a line diverging thereout at or near a point 90 yards or thereabouts, from the termination of such siding in the said parish of Claines, and passing along the Quays on the eastern side of the river to or near to the Deanery in the parish of St. Alban, all in the city of Worcester: and which said siding and works will be situate in, or pass from, in, through, and into the parishes, townships, and extra-parochial places of St. Nicholas, St. Clement, Whistones, Claines, All Saints, St. Andrew and St. Alban, or some of them, all in the city and county of the city of Worcester.

In such Bill powers will be sought with reference to such siding and works for the following purposes, or any of them; that is to say:

To purchase, by compulsion, lands and houses for the purposes of the intended siding and works, and to levy rates, tolls, and duties for the use of the same;

To authorize the Company to apply to the completion of the siding and works to be authorized under the powers so sought to be introduced into the said Bill, any part of the moneys which they are authorized to raise by the Acts, or any of them, relating to the Company, and to amend the provisions of such Acts accordingly.

Maps, plans, and sections, showing the direction, line, and levels of the proposed siding and works, and the lands to be taken for the purposes thereof, with books of reference to the plans, containing the names of the owners, lessees, and occupiers of those lands, and a copy of this notice, has been in this month of April deposited for public inspection with the Clerk of the Peace for the city and county of the city of Worcester, at his office at Worcester; and a copy of the said plans, sections, and books of reference, with a copy of this notice, with the parish clerks of the parishes aforesaid, at their respective residences.
