Whitehaven and Junction Railway.

(Additional Provision; Deviation of Branch at the Harbour of Maryport.)

NOTICE is hereby given, that in pursuance of a resolution of the Select Committee on Standing Orders, agreed to by the House of Commons in the present session, an additional provision will be made in the Bill now depending under the short title of "The Whitehaven Junction Railway—New Branches," whereby power will be taken to alter and deviate the said branch railway at the harbour of Maryport, firstly described in the said Bill, and as delineated on the plans and sections deposited with the Clerk of the Peace for the county of Cumberland, in the month of November last, in manner following (that is to say):-Instead of commencing at or near to Risehow Cottage, in the parish of Flimby, in the county of Cumberland, and passing in the line and terminating at or near to the north end of the quay or jetty at the north-west end of the dock basin, in the harbour of Maryport, township of Ellenborough, parish of Dearham, and county of Cumberland, as laid down in the said plan, the same will now commence by a junction with the Whitehaven Junction Railway, at or near the north side of the present Risehow level crossing, in the said parish of Flimby, and will deviate and pass in the line laid down on the plan or section to be deposited as hereinafter mentioned, through and will be situate within the several parishes or townships of Flimby, Dearham, and Ellenborough, in the said county, and will terminate at the south-west corner of the coal depôt in the occupation of Joseph Harris, Esquire, situate upon or adjoining the western quay of the dock basin, in the said harbour of Maryport, in the same township, parish, and county : And for the purpose of such deviation, it is intended to divert and alter the said present Risehow level crossing, to a point on the said Whitehaven Junction Bailway, immediately on the north of the said junction, as shewn on the last-mentioned plan, in the said parish of Flimby : and so to amend the Bill as to give effect to such intended alteration and deviation.
