**REGISTRY OF ORDERS OF PROTECTION OF PROPERTY OF DESERTED MARRIED WOMEN.**

THE Lords of the Treasury have directed that a Registry is to be kept in every County Court, of all Orders for the Protection of Property of Deserted Married Women entered under the 21st section of the 20th and 21st Vict., cap. 85, with the Registrar of the Court, where the same may be inspected by any person desirous of so doing; and further that a copy of the entry in the County Court shall be sent to the office of the Central Registry of County Court Judgments, at No. 2, New-street, Spring-gardens, London, S.W., to be there registered, so as to enable for the future creditors and others to ascertain whether a married woman has obtained protection of her property, and to render unnecessary inquiry at the several County Courts within the districts of which she may have dwelt since 1857.

**NAVAL PRIZE MONEY.**

NOTICE is hereby given to all persons interested therein, that preparations are now making

**Great Southern of India Railway Company.**

(New Powers; definition, qualification and alteration of existing powers; reincorporation and regulation of Company; arrangements with Governing Bodies.)

NOTICE is hereby given, that application is intended to be forthwith made to Parliament for leave to bring in a Bill to reincorporate the members of the Great Southern of India Railway Company (Limited) by the name of the Great Southern of India Railway Company, or by some other name, for the purpose of affording railway communication to southern India by the construction, maintenance and working of railways, and of effecting all matters and things incidental or conducive thereto; to incorporate and apply to the said Company the provisions of the "Companies Clauses Consolidation Act, 1845," in lieu of those of the "Joint Stock Companies Acts, 1856-1857," and of their memorandum and articles of association; to enable them to appoint directors and other officers in and for India, and to establish offices in India for the issue, transfer, and registration of shares and securities and payment of dividends in India; to regulate and define the domicile, constitution, and management of the Company, their capital and powers of raising money by shares and borrowing, the locality of shares and securities, and the authorizing of proxies; to sanction and give effect to contracts and arrangements between the Company and the Honourable East India Company, Her Majesty's Government, the Supreme and Local Governments of India, and other bodies and persons with reference to the promotion, execution, working, and use, surrender, sale, and leasing, supervision and control of the undertaking of the Company, the guarantee of interest and dividends on their capital and loan, or any part thereof, the appointment of ex-officio directors of the Company, interchange of the traffic with other Companies, facilities over, use and working of other lines, reciprocally or otherwise, and any other matters incidental to, or connected with, the objects aforesaid; to confer upon the Company other rights and privileges, and to vary
