

that if it shall appear to us to be expedient, at any future time, that instead of the annual sum then in course of payment by us to the incumbent of any benefice or church, or instead of any part of such annual sum, a gross sum equivalent thereto should be substituted, or any land, tithe, or other hereditament should be conveyed to such

benefice or church in fee, nothing herein or in any other Scheme contained shall prevent us from recommending and proposing such a substitution, or from recommending and proposing any other measures relating to the matters aforesaid or any of them, in accordance with the provisions of the said Act or of any other Act of Parliament."

THIRD SCHEDULE.

All that yard, garden, and croft, containing together two roods and six perches, situate in the parish of Wolvey, in the county of Warwick, and adjoining the vicarage house there, which said

premises were late in the occupation of Mrs. Mary Winterton, as tenant of the Ecclesiastical Commissioners for England.

FOURTH SCHEDULE.

All that triangular piece or parcel of land lying on the north side of the Finchley Road, in the county of Middlesex, bounded on the east and north sides thereof by land belonging to the district chapelry of All Saints, Child's Hill, Hendon, and on the west by land belonging to the Ecclesiastical Commissioners for England, and measuring on the east side thereof two hundred and seventy-six feet, or thereabouts; on the north side thereof one hundred and thirty feet, or thereabouts; and on the west side thereof three hundred and five feet, or thereabouts. And also all

that other triangular piece or parcel of land lying on the south side of Child's Hill Lane, in the same county, bounded on the east side thereof by land belonging to the said district chapelry of All Saints, Child's Hill; on the west side thereof by land belonging to the said Commissioners; and on the north side thereof by Child's Hill Lane aforesaid, and measuring on the east side thereof four hundred and ninety feet, or thereabouts; on the west side thereof four hundred and eighty-five feet, or thereabouts; and on the north side thereof seventy-five feet, or thereabouts.

FIFTH SCHEDULE.

All those two several small pieces of freehold land adjoining the vicarage house of Godmersham, called Love Town, and Island Meadow, containing respectively one acre and eleven perches, and three roods and seventeen perches, and together, one acre three roods and twenty-eight perches; and also all that piece of land, called the Islands, containing three roods and thirty-five perches, or thereabouts; and also all that piece of land containing two roods and five perches, or thereabouts, part of an orchard adjoining the said vicarage house of Godmersham, with their appurtenances, which
