

hereinafter mentioned would be a just and reasonable compensation for such diminution.

"Now, therefore, we humbly recommend and propose, that there shall be paid by us to the Reverend Alfred Brown, vicar or incumbent of the vicarage of the parish of Calverley, in the county of York, and in the diocese of Ripon, so long as he shall remain such vicar or incumbent, and no longer, the annual sum of nine pounds, by way of compensation for the loss of fees, dues, or other emoluments, sustained by him as such vicar or incumbent, by reason of the formation of the new parish of Saint Paul, Pudsey, by equal half-yearly payments, on the first day of May and the first day of November in each year.

"And we further recommend and propose, that there shall be paid by us to the Reverend Cuthbert Edgcombe Hosken, formerly vicar or incumbent of the vicarage of the parish of Saint Blazey, in the county of Cornwall, and in the diocese of Exeter, the sum of thirteen pounds, two shillings, and one penny, by way of compensation for the loss of fees, dues, or other emoluments, sustained by him when vicar or incumbent of the said vicarage, by reason of the formation of the new parish of Par.

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Act, or of any other Act of Parliament."

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same, and every part thereof, shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the respective Registrars of the dioceses of Exeter and Ripon.

The QUEEN's Most Excellent Majesty in Council.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act of the sixth and seventh years of Her Majesty, chapter thirty-seven, sections six and eight, duly prepared and laid before Her Majesty in Council a scheme, bearing date the twenty-ninth day of April, in the year one thousand eight hundred and fifty-eight, in the words following, that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act of the sixth and seventh years of your Majesty, chapter thirty-seven, sections six and eight, have prepared, and now humbly lay before your Majesty in Council, the following scheme for authorizing the sale of certain property belonging to the prebend of Combe and Harnham, with the prebend of Ruscombe Northbury annexed, in the cathedral church of Salisbury.

"Whereas on the next avoidance of the said prebends, which are now held by the Honourable and Reverend Lord Charles Paulet, all the lands, tenements, hereditaments, and endowments, belonging to such dignities (except any right of ecclesiastical patronage), will become vested in us, subject to any legally subsisting lease or leases thereof.

"And whereas application has been made to us for the purchase of all our estate and interest in certain portions of the said lands, tenements, and hereditaments; and after due consideration it appears to us to be expedient that we should be empowered to dispose of our interest therein, or in any part or parts thereof, in such manner as shall appear to us to be advisable.

"We, therefore, humbly recommend and propose, that we may be authorized and empowered by instrument or instruments in writing, duly executed according to law, and so long as the said Lord Charles Paulet shall, as such prebendary continue to hold the estates of the said prebends, with his consent, testified by his being made party to such deed or deeds, from time to time to sell, or dispose of, and duly to convey, according to the provisions of the said Act, all or any of the said lands, tenements, hereditaments, or endowments heretofore belonging to the said prebends, so to become vested in us as aforesaid, with their appurtenances, and all our estate, right, title, and interest therein, or in any part or parts thereof, unto and to the use of any person or persons desirous or willing to purchase the same, and his or their heirs, executors, administrators, or assigns, or otherwise as he or they shall direct or appoint, and for such consideration as shall upon due calculation and inquiry appear to us to be just and reasonable.

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Act, or of any other Act of Parliament."

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same, and every part thereof, shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the diocese of Salisbury.
