THEREAS by an Act, passed in the session of Parliament held in the sixth and seventh years of the reign of His late Majesty King William the Fourth, intituled "An Act for rendering "more easy the taking the poll at county elections," it is enacted that it shall be lawful for His Majesty, by and with the advice of His Privy Council, from time to time, on petition from the Justices of any county, riding, parts, or division in England or Wales, in quarter sessions assembled, representing that the number of polling places for such county, riding, parts, or division, is insufficient, and praying that the place or places mentioned in the said petition may be a polling place or poling places for the county, riding, parts, or division of the county within which such place or places is or are situate, to declare that any place or places mentioned in the said petition shall be a polling place or polling places for that county, riding, parts, or division; and that the Justices of the Peace for such county, riding, parts, or division, in quarter sessions or some special sessions assembled, as mentioned in the Act passed in the second and third years of the reign of His said late Majesty, intituled "An Act to settle and determine the "divisions of counties and the limits of cities and "boroughs in England and Wales, in so far as

"respects the election of members to serve in "Parliament," shall, conformably to the said last-mentioned Act, divide such county, riding, parts, or division into convenient polling districts, and assign one of such districts to each polling place:

And whereas the Justices of the Peace of the

And whereas the Justices of the Peace of the county of Wilts, in quarter sessions assembled at Warminster, on the twenty-ninth day of June last, have presented a petition to Her Majesty, representing that the number of polling places for the southern division of the said county of Wilts was insufficient, and praying that Westbury may be a polling place for the said division, within which such place is situate:

Now, therefore, Her Majesty, having taken the said petition into consideration, is pleased, by and with the advice of Her Privy Council, to declare, order, and direct, and it is hereby declared, ordered, and directed, that Westbury shall be a polling place for the southern division of the county of Wilts; and that the Justices of the Peace for the said county, in quarter sessions or some special sessions assembled, as mentioned in the said Act passed in the second and third years of the reign of His said late Majesty, shall, conformably to the said Act, divide such division into convenient polling districts, and assign one of such districts to each polling place.

HEREAS by an Act, passed in the session of Parliament, held in the eighteenth and nineteenth years of Her Majesty's reign, intituled "An Act further to amend the "laws concerning the burial of the dead in "England" it is, amongst other things, enacted that it shall be lawful for Her Majesty, by and with the advice of Her Privy Council, from time to time, to postpone the time appointed by any Order in Council for the discontinuance of burials, or otherwise to vary any Order in Council made under any of the Acts recited in the said Act, or under the said Act (whether the time thereby appointed for the discontinuance of burials thereunder, or other operation of such Order, shall or shall not have arrived), as to Her Majesty, with such advice as aforesaid, may seem fit;

And whereas certain Orders in Council have been made, directing the discontinuance of burials in the churchyards and burial-grounds hereinafter mentioned from the time mentioned in such Orders respectively; and whereas it seems fit to Her Majesty, by and with the advice of Her Privy Council, that the time for discontinuing burials in the said churchyards and burial-grounds be postponed;

Now, therefore, Her Majesty, by and with the advice aforesaid, is pleased to order, and it is hereby ordered, that the time for the discontinuance of burials in such churchyards and burial-grounds be postponed as follows; viz.:

In the churchyard of the parish of CLAYBROOK, from the first of October next to the first of June, one thousand eight hundred and fiftynine;

In the churchyard of the parish of GILLINGHAM, Kent, from the first of September, instant, to the first of January, one thousand eight hundred and fifty-nine;

In the churchyard of Melbourne, Derbyshire, in the Friends Burial-Ground, in the New Jerusalem Chapel Burial-ground, and in the Baptist Chapel Burial-ground, in that parish, from the first of September instant, to the first of May, one thousand eight hundred and fifty-nine;

In the new portion of the churchyard at All Saints, Newmarket, and in the new burial-ground in St. Mary's Parish in that town, from the first of August to the first of November, one thousand eight hundred and fifty-eight;

In the churchyard of the parish of Selby, from the first of September to the first of November, one thousand eight hundred and fiftyeight:

In the parish churchyard and Vicarage Croft, in St. Andrew's Churchyard, in the burial-grounds of the Baptist, Zion, and Salem Chapels, and in the Old Friends' Burial-ground, all in WAKEFIELD, from the first of November next, to the first of May, one thousand eight hundred and fifty-nine;

And whereas by an Order in Council of the eighth of June, one thousand eight hundred and fifty-four, burials were directed wholly to cease in the churchyard of All Saints, Chorlton, in MAN-CHESTER, from and after the first of March, one thousand eight hundred and fifty-six, and the said Order was varied by an Order of the twentyseventh of August, one thousand eight hundred and fifty-seven, and it seems fit that the same be again varied; now, therefore, Her Majesty, by and with the advice of Her Privy Council, is pleased to order, and it is hereby ordered, that interments in All Saints Churchyard, Chorlton, in Manchester, be discontinued from and after the first day of July, one thousand eight hundred and fifty-nine; and forthwith, except in now existing private vaults and brick graves, in which each coffin shall be embedded in charcoal, and separately entombed in an air-tight manner, and except in private family graves in which no coffin shall be buried within a foot of any other coffin, or four feet of the surface of the ground; and it is further ordered, that none be buried in any grave or vault except widowers, widows, parents, children, brothers or sisters of those already interred therein, and that the entire surface of the ground, not occupied by stones or walks, be covered with soil, and a living vegetation maintained.

And whereas by an Order in Council of the eighteenth of October, one thousand eight hundred and fifty-four, burials were directed to be discontinued from and after the first of June then next, in the churchyard of St. Edmund, Salisbury, except as was therein excepted, and such time was afterwards postponed to the first of February, one thousand eight hundred and fifty-eight, and it seems fit that the said Order be varied; now, therefore, Her Majesty, by and with the advice aforesaid, is pleased to order, and it is hereby ordered, that interment in the said churchyard of St. Edmund, Salisbury, be discontinued, except for the burial of the widowers, widows, parents, and unmarried children, of those already buried in now existing catacombs, vaults, and walled graves, in which each coffin shall be imbedded in charcoal, and separately entombed in an air-tight manner, and in family graves not less than five feet deep, which can be opened without the exposure of human remains.

THEREAS the Right Honourable Spencer Horatio Walpole, one of Her Majesty's Principal Secretaries of State, after giving to the Incumbents and the Churchwardens of the parishes hereinafter mentioned ten days' previous notice of his intention to make such representations, has, under the provisions of an Act, passed in the session of Parliament held in the sixteenth and seventeenth years of Her Majesty's reign, intituled "An Act to amend the laws concerning "the burial of the dead in England beyond "the limits of the metropolis, and to amend the "Act concerning the burial of the dead in the "metropolis," made two representations stating that, for the protection of the public health, no new burial-ground should be opened in any of the undermentioned parishes without the previous approval of one of Her Majesty's Principal Secretaries of State, and that interments in the same should be discontinued, with the following modifications:

GATESHEAD.—Forthwith in the churchyards of St. Edmunds and St. Cuthberts, Gateshead, except so far as is compatible with the observance of the regulations for new burial-grounds, omitting No. 3.

LEDBURY.—Forthwith in the parish church, and also in the churchyard, and Baptist Burial-ground, Ledbury, except in graves not less than five feet deep which can be opened without the disturbance of remains,—and that no grave be dug within three yards of any dwelling.

HORTON, NORTHUMBERLAND.—In the parish churchyard on the first day of November, one thousand eight hundred and fifty-eight, except in graves and vaults which are free from water, no graves to be less than five feet deep, and no remains to be disturbed, and that the churchyard be properly drained.

STAINDROP.—Forthwith in the parish church of Staindrop; and also in the churchyard, except in that part which is to the north of the church, on and after the first day of March, one thousand eight hundred and fifty-nine.

COLCHESTER, St. BOTOLPH'S.—Forthwith in the Garrison Burial-ground, except so far as they may be conducted in accordance with the 7th Official Regulation for Burial-grounds.

ROCHDALE. - Forthwith in the parish church of

Rochdale.

Whalley.—Forthwith wholly in the church of Haslingden, and also in such part of the churchyard as is within three yards of any dwelling, and in the rest of the churchyard, except so far as is compatible with the observance of the regulations for new burial-grounds, numbers 5, 6, 7 and 8; and that in the Independent, Wesleyan and Baptist Burial-grounds, in Haslingden, interment be discontinued, except in graves never previously opened, and existing family graves which can be opened not less than five feet deep without exposure of remains, and family vaults or walled graves in which each coffin shall be embedded in charcoal, and separately entombed in an airtight manner.

Now, therefore, Her Majesty in Council is pleased hereby to give notice of such representations, and to order that the same be taken into consideration by a Committee of the Lords of Her Majesty's Most Honourable Privy Council, on the sixteenth day of October next;

And Her Majesty is further pleased to direct that this Order be forthwith published in the London Gazette; and that copies thereof be affixed on the doors of the churches or chapels of, or on some conspicuous places within, the parishes affected by such representations, one month before the said sixteenth day of October.

HEREAS the Local Board of Health for the district of HECKMONDWIKE, in the West Riding of the county of York, established under "The Public Health Act, 1848," have, under the provisions of an Act passed in the session of Parliament held in the twentieth and twenty-first years of Her Majesty's reign, intituled "An Act to amend the Burial Acts," presented a petition to Her Majesty in Council, stating that the district of the said Local Board of Health is coextensive with the township of Heckmondwike aforesaid, and that it is proposed to provide a new burial-ground for the said district; that no burial board has been appointed for the said district; and that an Order in Council has been made for closing the churchyard of Saint James, Heck-mondwike, from and after the first day of March, one thousand eight hundred and fifty-nine, with certain exceptions in such Order mentioned; and praying that Her Majesty would be pleased to order that the said Local Board of Health may be a burial board for the district of such local

Now, therefore, Her Majesty in Council is pleased hereby to give notice of such petition, and to order that the same be taken into consideration by a Committee of the Lords of Her Majesty's Most Honourable Privy Council, on the fifteenth day of October next.

And Her Majesty is further pleased to direct that this Order be published in the London Gazette, and in one of the newspapers usually circulating in the district of such Local Board of Health as aforesaid, one month at least before the said fifteenth day of October next.

The QUEEN's Most Excellent Majesty in Council.

WHEREAS by an Act, passed in the session of Parliament, held in the twentieth and twenty-first years of Her Majesty's reign, intituled "An Act "to amend the Burial Acts," it is, amongst other things, enacted that it shall be lawful for Her Majesty, upon the representation of one of Her Majesty's Principal Secretaries of State, by and with the advice of Her Privy Council, from time to time, to order such acts to be done by, or under the directions of, the churchwardens or such other persons as may have the care of any vaults or places of burial, for preventing them from becoming or continuing dangerous or injurious to the public health; and that every such Order in Council shall be published in the London Gazette, and that such churchwardens or other persons shall do, or cause to be done, all acts ordered as aforesaid, and the expenses incurred in and about the doing thereof, shall be paid out of the poor rates of the parish; provided always, that no such representation should be made until ten days' previous notice of the intention to make such representation should have been given to the church-wardens or other persons, or one of the churchwardens or other persons, having the care of the vaults or places of burial to which the representation relates;

And whereas the Right Honourable Spencer Horatio Walpole, one of Her Majesty's Principal Secretaries of State, after ten days' previous notice of his intention to make such representation had been duly given to the incumbent and churchwardens, or other persons having the care of the vaults under the church of Saint Margaret, Westminster, has made a representation, stating that he was of opinion that, for the purpose of preventing the said vaults from becoming or continuing dangerous or injurious to the public health, the Acts hereinafter set forth should be done in respect of such vaults;

Now, therefore, Her Majesty, by and with the advice of Her Privy Council, is pleased to order, and it is hereby ordered, that the churchwardens or such other person as may have the care of the vaults under the said Church of Saint Margaret, Westminster, do adopt, or cause to be adopted, the following measures in respect of such vaults; viz.:

That all the coffins deposited in the vaults beneath the church of Saint Margaret, Westminster, be completely covered with fresh soil, mixed with powdered charcoal, or with McDougall's disinfecting powder, and entombed by concrete, brick, or stone work in an air-tight manner, and the vaults lime-washed, their entrances from the church closed by brick or stone work, and ventilating shafts constructed, and that the work be executed under the superintendence of Mr. Holland, Inspector of Burial-grounds.

THE Queen has been graciously pleased to signify Her intention to confer the Decoration of the Victoria Cross on the undermentioned Officer and Soldier, who have been recommended to Her Majesty for that Decoration on account of Acts of Bravery performed by them in India, as recorded against their respective names; viz.:

Regiment or Corps.	Rank and Name.	Act of Bravery for which recommended.
4th Bengal Native Infantry	Lieutenant (now Captain) Frederick Robertson Aikman Date of Act of Bravery, 1st March, 1858	This Officer, Commanding the 3rd Sikh Cavalry on the advanced Picquet, with one hundred of his men, having obtained information, just as the Force marched on the morning of the 1st of March last, of the proximity, three miles off the high road, of a body of 500 Rebel Infantry, 200 Horse, and 2 Guns, under Moosahib Ali Chuckbdar, attacked and utterly routed them, cutting up more than 100 men, capturing two guns, and driving the survivors into, and over, the Goomtee. This feat was performed under every disadvantage of broken ground, and partially under the flanking fire of an adjoining Fort. Lieutenant Aikman received a severe sabre cut in the face in a personal encounter with several of the enemy.
Bengal Horse Artillery	Gunner William Connolly Date of Act of Bravery, 7th July, 1857	This Soldier is recommended for the Victoria Cross for his gallantry in Action with the Enemy, at Jhelum, on the 7th of July, 1857. Lieutenant Cookes, Bengal Horse Artillery, reports, that "about daybreak on that day, I "advanced my half Troop at a gallop, and "engaged the Enemy within easy musket "range. The Sponge-man of one of my "Guns having been shot during the advance, "Gunner Connolly assumed the duties of 2nd "Sponge-man, and he had barely assisted in "two discharges of his Gun, when a musket-"ball, through the left thigh, felled him to the "ground; nothing daunted by pain and loss of blood, he was endeavouring to resume his "post, when I ordered a movement in retirement, and though severely wounded, he was "mounted on his horse in the Gun-team, and "rode to the next position which the Guns "took up, and manfully declined going to the "rear when the necessity of his so doing was "represented to him. "About eleven o'clock, A.M., when the Guns "were still in Action, the same Gunner, "whilst sponging, was again knocked down "by a musket-ball striking him on the hip, "thereby causing great faintness and partial "unconsciousness, for the pain appeared excessive, and the blood flowed fast. On "seeing this, I gave directions for his removal "out of Action; but this brave man hearing "me, staggered to his feet, and said, 'No, Sir, "i'll not go there, whilst I can work here,' "and shortly afterwards he again resumed his "post as Sponge-man. "Late in the afternoon of the same day, "my three Guns were engaged at one hundred "yards from the Walls of a Village with the "defenders, viz., the 14th Native Infantry—"Mutineers—amidst a storm of bullets which "did great execution. Gunner Connolly, "though suffering severely from his two pre-"vious wounds, was wielding his sponge with "an energy and courage which attracted the "admiration of his comrades, and while cheer-"fully encouraging a wounded man to hasten "in bringing up the ammunition, a musket-

Bengal Horse Artillery	Gunner William Connolly— (continued)	"ball tore through the muscles of his right "leg; but with the most undaunted bravery "he struggled on; and not till he had loaded "six times, did this man give way, when, "through loss of blood, he fell in my arms, "and I placed him on a waggon, which "shortly afterwards bore him in a state of "unconsciousness from the fight."

HEREAS the Master and Fellows of Pembroke College, in the University of Oxford, have, under the provisions of an Act, passed in the 19th and 20th years of Her Majesty's reign, intituled "An Act to amend the "Act of the seventeenth and eighteenth years of "Her Majesty, concerning the University of Ox-"ford and the College of Saint Mary, Winches-"ter," made the following Ordinance, to amend an Ordinance made by the Oxford University Commissioners, under the 17th and 18th Vict., cap. 81, in relation to Pembroke College aforesaid, dated the 19th of February, 1857, and approved by an Order in Council of the 25th of June following; and whereas the said Ordinance was, on the 9th of June last, approved by the said Commissioners, and has been this day laid before Her Majesty in Council, the same is published in pursuance of the said Acts; And Notice is hereby given, that it is lawful for the bodies or persons mentioned in the \$55th section of the last recited Act, within one month after this publication, to petition Her Majesty in Council against the approbation of the said Ordinance, or of any part thereof.

ORDINANCE ABOVE REFERRED TO.

WHEREAS, the Commissioners appointed for the purposes of an Act passed in the seventeenth and eighteenth years of the reign of Her Majesty Queen Victoria, intituled "An Act to make further provision for the Good Government and Extension of the University of Oxford, of the Colleges therein, and of the College of Saint Mary, Winchester," framed and settled an Ordinance in relation to Pembroke College, in the said University, dated the nineteenth day of February, one thousand eight hundred and fifty-seven, which Ordinance was duly approved by Her Majesty in Council on the twenty-fifth of June, one thousand eight hundred and fifty-seven; and whereas, the said Ordinance contains the following clauses:

"36. The Elections to the Scholarships to be maintained out of the common fund (others than the Abingdon Scholarships), shall take place annually in Hilary Term, on a day to be fixed by the Master (subject! to the provision for postponement hereinafter contained), and notice of such intended election shall be given by the Master, in such manner as he shall deem best adapted to ensure publicity, thirty days at least before the day of election.

"47. Whenever a King Charles the First's Scholarship, an Abingdon Scholarship, a Bishop Morley, Rous or Holford Scholarship, or a Scholarship of George Townsend's foundation shall be vacant; and no candidate shall offer himself for such scholarship, duly qualified by nomination or otherwise, according to the foregoing provisions, or in case of a Townsend Scholarship, qualified according to the

instrument of Foundation of these Scholarships, (as the case may be,) whom the electors shall judge of sufficient merit for election, such scholarship shall be thrown open for that term, and the Election shall be postponed to a day to be fixed by the Master and Fellows, not later than the next ensuing day of Election to the Scholarships (other than the Abingdon Scholarships), to be maintained out of the Common Fund, and shall be conducted in the same manner, and after the same previous notice as the Election to such Scholarship."

And whereas, by an Act passed in the nineteenth and twentieth years of the reign of Her Majesty Queen Victoria, intituled "An Act to amend the Act of the seventeenth and eighteenth years of Her Majesty, concerning the University of Oxford and the College of Saint Mary, Winchester," it is enacted that it shall be lawful for any College, of or in relation to which any regulation, ordinance, or statute, shall have been applied by Her Majesty in Council, under section thirty-six of the said Act, from time to time, with the approval of the Commissioners, and during the continuance of their powers under the said Act, to amend or alter such regulation, ordinance, or statute, subject to the same conditions and provisions as are imposed by the Act, in relation to the making of the original regulation, ordinance, or statute.

And whereas it is expedient that the said Ordinance of the nineteenth of February, one thousand eight hundred and fifty-seven, should be amended as hereinafter mentioned.

We, the Master and Fellows of Pembroke College aforesaid, ordain as follows:—The said Ordinance of the nineteenth day of February, one thousand eight hundred and fifty-seven, shall henceforth be read as if in lieu of the clauses hereinbefore set forth, there had been inserted the clauses following.

"36. The Elections to the Scholarships to be maintained out of the Common Fund, (other than the Abingdon Scholarships), shall take place on a stated day or stated days in each year, to be appointed, from time to time, by the Master and Fellows, subject to the provisions for postponement hereinafter contained, and notice of such intended Election shall be given by the Master, in such manner as he shall deem best adapted to secure publicity, thirty days at least before the day of election.

"47. Whenever a King Charles the First's Scholarship, an Abingdon Scholarship, a Bishop Morley, Rous or Holford Scholarship, or a Scholarship on George Townsend's Foundation shall be vacant, and no candidate shall offer himself for such Scholarship, duly qualified by nomination or otherwise, according to the foregoing provisions; or, in the case of a Townsend Scholarship, qualified according to the Instrument of Foundation of these Scholarships (as the case may be), whom the Master and Fellows shall judge of sufficient merit for election, such Scholarship shall be thrown open for that term; and the Election shall be post-

poned to a day, to be fixed by the Master and Fellows, not later than the next ensuing stated day of Election to the Scholarships (other than the Abingdon Scholarships), to be maintained out of the Common Fund, and shall be conducted in the same manner, and after the same previous notice, as the Election to open Scholarships: Provided always, that the emoluments of every Scholar so elected, as last aforesaid, shall accrue from the same time as if being qualified by nomination or otherwise, he had been elected on the day on which the Election would have taken place, if there had been no postponement, and shall not in any case, be enjoyed for more than five years, to be computed from that day."

NOTICE TO MARINERS.

THE Lords of the Committee of Privy Council for Trade have received, through the Secretary of State for Foreign Affairs, copy of a Notice, issued by the Netherlands Minister of Marine, descriptive of a Bell-Beason, recently placed near the

Schouwen Bank, in the North Sea. A translation is subjoined.

(Translation.)

A bell-beacon, constructed of iron, in the form of a boat, painted black, has recently been moored in the North Sea, near the N.E. end of the "Schouwen Bank."

On the mast are fixed two triangles of trelliswork (treillages) one placed fore and aft, and the other athwart-ships, and painted with horizontal stripes, white and black alternately.

One of the black stripes bears the inscription "Schouwen-Bank," and one of the white stripes "W. Schouwen, Z. O. misw."

At the mast-head are two black wings of elliptical form, crossing at right angles, between which is suspended a large bell, the loud and deep sound of which serves as a warning at night, and in

foggy weather.

The height of the whole is more than metres, or about 20 feet above the level of the sea, and will be visible in clear weather at a distance of about 2 geographical leagues, or

8 English miles.

The beacon is moored in 26 metres, about $12\frac{1}{2}$ fathoms, at ordinary low water, in latitude 51 47' N., and longitude 3° 27' E. (Greenwich).

The bearings (magnetic) are as follows: Schouwen revolving light, S.E. West-Kasselle Light S. by W. 3 W.
