**D**ESPATCHES, of which the following are copies, have been received by the Lords Commissioners of the Admiralty, from Captain Sotheby, commanding Her Majesty's ship Pearl's Naval Brigade in India.

*Camp Bustee,  
October 20, 1858.*

SIR,

I HAVE the honour to forward, with much satisfaction, for the Lords Commissioners of the Admiralty's information, the accompanying report (Sub-enclosure and 3) from the officers in charge of detachments of the Pearl's Naval Brigade, and feel assured their Lordships will perceive how much they have contributed to the success of this field force. The roads, owing to the floods, were at times nearly impassable, scarcely any carriage being able to move, the guns were transported on elephants.

Much praise is due to the officers and men for their great exertions, in which Brigadier Fisher, in command, fully concurs. In report No. 2, I beg especially to bring to the notice of their Lordships the conduct of John Lee (A.B.), as therein mentioned, as also James Williams (L.S.), captain of the gun, who always presses forward most eagerly.

September 20, 1858.*

SIR,

I HAVE the honour to acquaint you that I left this place at 4 P.M., on the 6th instant, in charge of a portion of the Pearl's Naval Brigade, accompanied by the detachment named in the margin,\* in pursuance of field force orders to march with all expedition to the relief of Bansee.

On reaching Goutah, 12 miles from Bansee, Captain Mulcaster joined with a squadron of

cavalry and took command. We arrived at Bansee on the 8th, having marched 50 miles in 39 hours, and found the enemy had retired on our approach.

The roads were very bad; in many places the men waded through two or three feet of water and once for 3 miles, besides two nullahs and one river to cross. On the 9th, a body of rebels advanced within 3 miles, and in conjunction with Captain Mulcaster, we crossed the Raptée with a portion of our force, they hearing of our approach retired, but the cavalry were able to cut up 40, principally sepoys. The guns and infantry, with every exertion, could not keep up, owing to the flooded and bad state of the roads, and great heat of the day. Brigadier Fisher, Madras N.I., took the command on the 10th and left Bansee on the 12th, with the view of getting in the rear of the rebels at Burgudwah.

When within three miles of Dumoorlahgunge our advanced guard was fired on by a strong force of rebels posted in a line of works commanding the road.

The guns were speedily got off the elephants, and galloped to the front.

We opened with shell, and were received by a well-directed fire of musketry. The enemy, however, deserted their works very soon, but from the state of the country the cavalry could not act. Having burnt their camp and levelled the works we proceeded to Dumoorlahgunge, on the bank of the Raptée, halted for the day, and crossed early the following morning, and were marching towards Etawah, when we found the road quite impassable; we, therefore, recrossed, and then heard that the rebels had fallen back to Beshohuer, in the jungle. The object being accomplished, we returned to Bustee on the 17th instant.

I must beg leave to express my great satisfaction at the very willing and cheerful conduct of the officers and men under most trying circumstances.

The great heat of the sun, and the exertion of wading through so much water, and being constantly wet, rendered it most harassing.

The following officers accompanied me, Acting Lieutenant A. W. Ingles, Mr. H. H. Edwards, Midshipman, and Mr. Parkins, Gunner.

*Camp Bustee,  
October 15, 1858.*

SIR,

I HAVE the honour to report for your information the proceedings of a detachment of the Pearl's Naval Brigade under my orders, from the 27th September to the 7th October. We left Bustee, at two A.M. of the 27th, with the force named in the margin,\* under the command of Captain Twynam. H.M.'s. 13th Light Infantry arrived at Bansee on the 28th, 40 miles, and crossed the Raptee at 9 P.M., and encamped in the entrenchments.

On the 29th we crossed the Paranassi Nuddee, and joined Captain Howlett's force, as per margin,† at one P.M. marched to Chetteah, where we halted for the night, the men and cattle being much fatigued from the heavy rain during all the day, and flooded state of the country. Next morning proceeded to Mowee, and thence towards the jungle; the cavalry came upon the rear guard of the rebels, 400, at the edge of it. The guns were got quickly to the front, and opened with shell, at 600 yards, and quickly dispersed them, and pursued them for six miles into the jungle, but it was impossible, owing to the nature of the country, to come up with them; we then halted, after a most harassing day.

Our object having been accomplished we returned to Bansee the following day, and marched back to Bustee on the 5th.

I have great pleasure in bringing to your notice the ready and obedient manner in which the detachment under my command performed this arduous and trying service, wading through a most flooded country and into thick jungle, during heavy rains with occasional hot sun.

Mr. H. H. Edwards, Midshipman, accompanied the expedition.

SIR,

*Amorha, October 2, 1858.*

I HAVE the honour to report for your information, the proceedings of the detachment of the Pearl's Naval Brigade under my command, engaged against the enemy at Amorha on the 1st instant.

At noon the patrol and villagers reported that the enemy, in number about 1200, were advancing in our front with others on either flank. Captain Gerrard of the 27th Madras Infantry, in command of the force as per margin,‡ moved out and took up a position in a village about 800 yards from camp; parties of infantry were thrown out on both flanks. The seamen and Seikhs, with the guns, formed our centre. The enemy, about 2 o'clock, commenced the attack from both flanks and centre, which they renewed several times, but were repulsed each time by the precision of the rifles, and our shells; at 4 o'clock they slackened their fire, and commenced retreating.

Captain Gerrard immediately followed them up with our horsed gun, at a gallop, supported by cavalry and Seikhs. We pursued them for about three miles and fired a few rounds of grape and case, with good effect. The cavalry charged and cut down several on our left. The infantry, not being able to keep up, a few of the guns' crews assisted the troopers attached to the gun with their rifles, especially John Lee, A.B., who was engaged with his cutlass against several sepoys, being unsupported for some little time, but who, I regret to say, while thus engaged, was severely wounded in the left arm.

From the bodies seen and the report of the natives the loss of the enemy is computed at about 200. The conduct of the men was most praiseworthy and the practice of the guns most accurate. Acting Lieutenant T. M. Maquay was in charge of the guns. Dr. Wilson in attendance on the wounded.

*Board of Trade, Whitehall,

THE Right Honourable the Lords of the Committee of Privy Council for Trade and Plantations have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Minister at Madrid, enclosing a translation of regulations, containing the following provisions, adopted by the Spanish Government, for levying Health, &c., dues on vessels in Spanish ports.

Vessels arriving from ports in the Mediterranean, and from other ports in Europe, including the Coast of Africa down to the latitude of the Canary Islands shall pay, on a voyage to and from, 50 centimes of real per ton.

Vessels arriving from any other ports than those mentioned above, shall pay on each voyage one real per ton.

#### *Quarantine Dues.*

Vessels of every description shall pay 25 centimes of a real per ton for every day of quarantine, as well in foul lazaretto, as in those of observation.

#### *Lazaretto Dues.*

Each person shall pay for his residence in the lazaretto a fee of 4 reales per day.

Goods and merchandize requiring to be purified shall pay, viz. :

The clothes and luggage of each individual of the crew, 5 réals.

The clothes and effects of each passenger, 10 reales.

Hides or cows' skins, 6 reales per hundred.

Fine skins, 6 reales per hundred.

Goat, sheep, lamb, and other coarse skins of small animals, 2 reales per hundred.

Feathers, hair, wool, rags, cotton, linen, and hemp, one real per quintal.

Large animals alive, such as horses, mules, &c., 8 reales each. Small animals, 4 reales each.

#### *Bill of Health Dues.*

Bills of health shall be issued and countersigned gratis.

#### *Observations.*

Vessels in quarantine shall defray separately the expenses occasioned by the unlading of the merchandize, its arrangement under the sheds, and its purification. They will also pay separately the expenses occasioned by the performance of the sanitary measures to be employed before the departure, or on the arrival of vessels, according to what may be enacted on this subject by the regulations, or to what the state of the vessel may require.

Every possible facility will be afforded to the vessels for these operations, and no expense whatever will be made without the knowledge or intervention of the captain, master, or consignee.

Persons performing quarantine in the Lazaretto shall defray the expenses which they may occasion, since the 4 reales per diem, which are levied on them, are only a fee for their residence.

ART. 2.—A round voyage (*Viage redondo*) is that which a vessel makes from her port of departure to that of her destination, and from the latter back to the former, without touching at any intermediate port either on going to or on coming back.

No advantages granted by the first and second provisions of the tariff are applicable to a voyage not made under the aforesaid circumstances.

ART. 4.—Sailing vessels, when intending to sail for a "round voyage," shall pay the entrance dues at the port of departure before receiving a bill of health, and they will be exempt from payment of such dues on their return, provided that their voyage shall not have altered its character by touching at some intermediate port, in which latter case they shall pay the dues again, according to the provisions of the tariff, and to the class and tonnage respectively of the vessel, and the circumstances of her navigation.

ART. 5.—The aforesaid sailing vessels shall also pay the entrance dues at every one of the ports

they may put into, whenever they may remain in them for upwards of 24 hours.

ART. 6.—Vessels remaining at a port for a longer period than 24 hours, if they are not comprised in the second case of Art. 12 of the present instructions, will have to pay the entrance dues, no matter whether they have a cargo on board or they are in ballast; and with no distinction whatever between those vessels which may discharge there the whole or part of their cargo, and those which may sail again with the same cargo on board.

ART. 7.—The entrance health dues shall be levied on the number of tons register of each vessel, and not on those of her cargo. The fractions of a ton will not be taken into account for the levying of health dues.

In all cases the legal ton will be understood to be equal to the capacity of one kilolitre.

ART. 8. For reducing into kilolitres the tons resulting from the system of measurement adopted by the marine in virtue of the Royal Order of 18th December, 1844, the number of tons shall be multiplied by 1,5184.

ART. 9.—Foreign transport vessels, although they may belong to their respective Governments, or be chartered for the account of the same, will be considered as merchant vessels, for the levying and payment of health dues.

ART. 10.—Steam vessels making regular periodical voyages, previously announced to the public, will be considered as coasting vessels, for the levying of entrance dues, and they shall only pay once the 25 centimes of a real per ton.

This payment shall take place at the port of departure, if such port is a Spanish one, or at the port of arrival, if the port of departure is a foreign one, every one of the steamer's full voyages being considered as a round voyage, no matter whether she touches at intermediate ports or not.

ART. 11.—Merchant vessels of every description, performing quarantine, shall pay (besides the quarantine and Lazaretto dues) the entrance dues, whenever, after the termination of the quarantine, they may put into the nearest port in the vicinity of the Lazaretto, and remain in it for upwards of twenty-four hours.

ART. 12.—No health dues whatever will be levied on ships of war, yachts of pleasure, vessels putting into ports by stress of weather, although admitted to free pratique, provided they perform no lading or unlading operation. The embarkation and landing of passengers shall not be considered as one of those operations.

ART. 14.—The four reales per diem marked in the tariff, for personal residence in the Lazarettos, will not be levied on persons belonging to the army or navy, either on active service, or on half-pay, or discharged from service, nor on public employés, either on active service, or on the retired list, nor children under seven years of age, nor on shipwrecked persons, nor on paupers, or individuals embarked at the expense of the Government of their country, and by their respective Consuls.

After payment of the health dues at the Custom House, the captain, master, or consignee of the vessel, shall go to the health office with the receipt which shall have been given to him at the former office, for the purpose of its being registered and stamped with the seal of the Board of Health, having the words "Con mi intervencion" (with my intervention) written on it, and signed by the health officer of the register.

Without the aforesaid requisite formalities, vessels will not receive the necessary authorization for their clearance.
