LOCAL GOVERNMENT ACT, 1858.

ORDER giving Notice of the Adoption of the Local Government Act, 1858, in the Township of FAIRFIELD, in the county of Derby, and excluding a Portion of the said Township from the Operation of the said Act, within the said Township, and stating the time at which the said Act is to come into force within the said Township.

WHEREAS a resolution was, on the 24th day of February, 1859, duly passed at a meeting of owners and ratepayers of the township of Fairfield, in the parish of Hope, in the county of Derby, adopting the Local Government Act, 1858, within the said township, after the parish of Hope had refused to adopt such Act;

And whereas a petition has been duly presented to me, as one of Her Majesty's Principal Secretaries of State, signed by not less than one-twentieth in number of the owners and ratepayers of the said township, such twentieth being also owners and ratepayers in respect of one-twentieth of the rateable property in such township, praying that a portion of the said township, shown on the map accompanying the said petition, should be excluded from the operation of the said Act, within the said township, the said portion being included within the boundaries set forth in another petition, for the settlement of a boundary under, and for the purposes of, the said Act, of a place to be called the Buxton District, for such purposes; and whereas the prayer of the first-mentioned petition has been duly inquired into and reported on by William Ranger, Esq., the Inspector appointed for such purpose;

Now, therefore, I, T. Sotheron-Estcourt, do hereby, in pursuance of the powers vested in me as one of Her Majesty's Principal Secretaries of State, under the provisions of the Local Government Act, 1858, make order as follows:

1. That the portion of the township of Fairfield aforesaid, described in the schedule to this Order annexed, shall be excluded from the operation of
