such Able and Ordinary Seaman, not above the age of forty-five, nor under the age of twenty years, who should, on or before the fifteenth day of June then following, enter themselves to serve in Her Majesty's Royal Navy, either with the Captains or Lieutenants of Her Majesty's Ships, or Officers employed in Tenders, or at Rendezvous on Shore for raising men for the service of the Royal Navy: and whereas Her Majesty was also graciously pleased by Her said Proclamation to declare that all Ablebodied Landsmen, not above the age of twenty-five, nor under the age of twenty years, who should so enter themselves as aforesaid, should receive the sum of Forty Shillings each man as Her Majesty's Royal Bounty:

And whereas the time limited by the said Proclamation for payment of the said Bounties will expire upon the fifteenth day of this instant June; and it being judged expedient for Her Majesty's service that the said Bounties should, so far as they relate to Able Seamen and Ordinary Seamen, be continued to be paid for some time longer, Her Majesty, with the advice of Her Privy Council, doth therefore order, and it is hereby accordingly ordered, that the time limited for payment of the said Bounties of ten pounds to Able Seamen, and of Five Pounds to Ordinary Seamen, be prolonged and extended from the said fifteenth day of this instant June to the thirty-first of July next inclusive; Whereof all persons concerned are to take notice and govern themselves accordingly.
