This day, the Lords being met, a message was sent to the Honourable House of Commons by the Gentleman Usher of the Black Rod, acquainting them that *The Lords authorized by virtue of a Commission under the Great Seal, signed by Her Majesty, for declaring Her Royal Assent to several Acts agreed upon by both Houses, do desire the immediate attendance of the Honourable House in the House of Peers to hear the Commission read*; and the Commons being come thither, the said Commission empowering the Lord Archbishop of Canterbury, and several other Lords therein named, to declare and notify the Royal Assent to the said Acts, was read accordingly, and the Royal Assent given to

An Act to apply the sum of ten millions out of the Consolidated Fund to the service of the year one thousand eight hundred and sixty.

An Act for taking the census in Scotland.

An Act to continue the Corrupt Practices Prevention Act (1854).

An Act to repeal so much of the Act of the twenty-second and twenty-third Victoria, chapter twenty-seven, and of certain other Acts, as authorizes the Secretary of State in Council to give directions for raising European forces for the Indian Army of Her Majesty.

An Act to continue the Poor Law Board.

An Act to provide for the management of East India Stock, and of the debts and obligations of the Government of India at and by the Bank of England.

An Act to provide for the management of the General Prison at Perth, and for the administration of local prisons in Scotland.

An Act to amend the Lands Clauses Consolidation Acts (1845) in regard to sales and compensation for land by way of a rentcharge, annual

feu duty, or ground annual, and to enable Her Majesty's Principal Secretary of State for the War Department to avail himself of the powers and provisions contained in the same Acts.
