Also, for having subsequently, near Sindhora, gallantly advanced with a Duffadar and Sowar of Beatson's Horse, and rescued from a band of robbers, a Potal, Chemmum Singh, whom they had captured and carried off to the Jungles, where they intended to hang him.

(No. 22.) NORTH ATLANTIC.—WEST COAST OF FRANCE.

Fixed Lights in the River Gironde.

THE Imperial Ministry for Public Works in France has given notice that on and after the 15th day of August, 1860, the following three alterations of lights, and six additional lights would be exhibited at the entrance of the river Gironde, on the eastern shore of the Bay of Biscay:—

Pointe de la Coubre.—Fixed white light; now raised to 121 feet above the level of high water; visible in clear weather at 15 miles. Lighthouse, 100 feet high; lat. 45° 41½' N., long. 1° 15' 24" West of Greenwich. At north point of entrance of River.

St. George.—Fixed red light; elevation 44 feet; visible 12 miles. Lighthouse, 26 feet high; lat. 45° 36' N., long. 1° 0' 38" W. Additional, on the east bank.

Suzac.—Fixed red light; elevation 121 feet; visible 12 miles. Lighthouse, 26 feet high; lat. 45° 35' 22" N., long. 0° 58' 53" W. Additional, on the east bank.

Pointe de Grave.—Fixed white light; now raised to 85 feet; visible 15 miles. Lighthouse, 82 feet high; lat. 45° 34' 10" N., long. 1° 4' 6" W. At south point of entrance.

Tallais Bank Light-Vessel.—Fixed white light; elevation 33 feet; visible 10 miles; lat. 45° 30' 42" N., long. 0° 59' 5" W. On west bank.

Tour-de-By Light-Vessel.—Fixed white light; elevation 33 feet; visible 10 miles; lat. 45° 23' 40" N., long. 0° 49' 20" W. Additional, on west bank.

Mapon Light-Vessel.—Fixed white light; elevation 33 feet; visible 9 miles. lat. 45° 17' 37" N., long. 0° 45' 56" W. Additional on west bank.

Ile de Patiras.—Fixed white light; elevation 43 feet; visible 13 miles. Lighthouse, 43 feet high; lat. $45^{\circ} 12' 22''$ N., long. $0^{\circ} 43' 0''$ W. Additional, on north point of Island.

Trompeloup.—A small fixed white light of 5 miles range, is exhibited on the old chapel of Trompeloup, to indicate the anchorage of Pauillac. Additional, on west bank.

DIRECTIONS.—To enter the Gironde at night, having ascertained the vessel's position by bearings of La Coubre and Cordouan lights, steer in through the Passe du Nord with the leading lights of Terre Nègre and Pontailac in one until La Coubre light bears N.N.E., when alter course towards Cordouan light until the leading lights of Falaise and Terre Nègre come in one. From thence the vessel must be navigated up the river by keeping these two latter lights and the following lights successively in line:—
