THE Queen has been graciously pleased to give orders for the appointment of Rutherford Alcock, Esq., Her Majesty's Envoy Extraordinary and Minister Plenipotentiary to the Tycoon of Japan, and Charles Alison, Esq., Her Majesty's Envoy Extraordinary and Minister Plenipotentiary to the Shah of Persia, to be Ordinary Members of the Civil Division of the Third Class, or Companions, of the Most Honourable Order of the Bath.

The Queen has also been pleased to approve of Mr. George W. Ewen as Consul in London for the Republic of Costa Rica.

By virtue of an Act, passed in the twenty-fourth year of the reign of His Majesty King George the Third, intituled "An Act to repeal so much of two Acts made in the tenth and fifteenth years of the reign of His present Majesty, as authorizes the Speaker of the House of Commons to issue his warrant to the Clerk of the Crown for making out writs for the election of Members to serve in Parliament, in the manner therein mentioned, and for substituting other provisions for the like purposes:"

I do hereby give notice, that it hath been certified to me in writing, under the hands of two

Members serving in this present Parliament, that the Honourable Charles Henry Gordon-Lennox, commonly called the Earl of March, late a Member serving in this present Parliament for the Western Division of the county of Sussex, is become a Peer of the United Kingdom, and that a writ of summons hath been issued to him, under the Great Seal of the United Kingdom, to summon him to Parliament; and that I shall issue my warrant to the Clerk of the Crown to make out a new writ for the electing of a Member to serve in this present Parliament for the said Western Division of the county of Sussex, at the end of fourteen days after the insertion of this notice in the London Gazette.
