The Queen has been pleased to grant unto Margaret Chamberlain, of Bramhope, in the West Riding of the county of York, Widow and Relict of Thomas Chamberlain, late of Halton East, in the said West Riding of the county of York, Esquire, and only surviving child of Robert Dyneley, late of Halton East, and of Bramhope aforesaid, Esquire, and sister and heir of John Dyneley, late of Bramhope aforesaid, Esquire, all deceased, Her Royal Licence and Authority that she and her issue may, in compliance with a direction contained in the last will and testament of her father, the said Robert Dyneley, take and use the surname of Dyneley only in lieu of that of Chamberlain, and that she and they may bear the arms of Dyneley, such arms being first duly exemplified according to the laws of arms, and recorded in the Heralds' Office, otherwise the said licence and permission to be void and of none effect:
