WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her Majesty, chapter forty-nine; and of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five, duly prepared and laid before Her Majesty in Council a representation, bearing date the thirteenth day of June, in the year one thousand eight hundred and sixty-one, in the words and figures following; that is to say:

We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of your Majesty, chapter forty-nine; and of the Act of the nineteenth and twentieth years of your Majesty, chapter fifty-five, have prepared and now humbly lay before your Majesty in Council, the following representation as to the assignment of a district chapelry to the consecrated church or chapel situate at Aberpergwm, in the parish of Cadoxtonjuxta-Neath, in the county of Glamorgan, and in the diocese of Llandaff.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church or chapel situate at Aberpergwm aforesaid.

"Now, therefore, with the consent of the Right Reverend Alfred Bishop of Llandaff, testified by his having signed and sealed this representation, we humbly represent, that it would, in our opinion, be expedient that all that part of the said parish of Cadoxton-juxta-Neath, described in the schedule hereunto annexed, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto also annexed, should be assigned to the said church or chapel, and that the same should be named 'The District Chapelry of Aberpergwm.'

"And with the like consent of the said Alfred Bishop of Llandaff, testified as aforesaid, we further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials, should be solemnized or performed at such church or chapel, and that the fees to be received in respect thereof should be paid and belong to the minister of the same church for the time being.

"We, therefore, humbly pray, that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such order with respect thereto as to your Majesty in your Royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Aberpergwm, being:-

"All that part of the parish of Cadoxton-juxta-Neath, in the county of Glamorgan, and in the diocese of Llandaff, wherein the present Incumbent of such parish now possesses the exclusive cure of souls, which is comprised within the hamlet of Neath Higher, and within that portion of the hamlet of Neath Middle which is situate to the east and north of an imaginary line commencing upon the boundary dividing such parish from the parish of Glyncorwg, in the same county and diocese, at a point in the middle of the Pentre-clwyda Brook, and extending thence in a direction generally northward up the middle of such brook to a boundary stone inscribed "A. D. C., 1861, No. 1," and placed on the eastern bank of the same brook near its source; and-extending thence north-westward and in a straight line to another boundary stone inscribed "A. D. C., 1861, No. 2," and placed on the eastern side of the old Roman road, called The Sarn Helen, and continuing thence in the last-mentioned direction and in a straight line to the boundary in such road dividing the said hamlet of Neath Middle from the hamlet of Dylais Higher, also in the said parish of Cadoxton-juxta-Neath."
