named 'The District Chapelry of Saint Stephen, South Lambeth.'

"And with the like consent of the said Charles Richard, Bishop of Winchester, testified as aforesaid, we further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials, should be solemnized or performed, at such church, and that the fees to be received in respect thereof should be paid and belong to the minister of the same church for the time being.

"We, therefore, humbly pray, that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such order with respect thereto as to your Majesty in your

Royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint Stephen, South

Lambeth, being :-

"All that part of the new parish of Saint Michael, Stockwell, in the county of Surrey, and in the diocese of Winchester, which is situate to the north and west of an imaginary line, extending along the middle of the Clapham-road."

Her Majesty having taken the said representation, together with the map or plan thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, and it is hereby ordered, that the proposed assignment of a district chapelry to the consecrated church of Saint Stephen, situate at South Lambeth, in the new parish of Saint Michael, Stockwell, in the county of Surrey, to be called "The District Chapelry of Saint Stephen, South Lambeth," be accordingly made, and that the recommendations of the said Commissioners, with reference to the publication of banns, and the solemnization of marriages, baptisms, churchings, and burials in the said church, and with reference to the fees to be paid in respect of those offices, be carried into effect agreeably to the provisions of the said Acts; and Her Majesty is further pleased to direct that this Order be forthwith registered by the Registrar of the diocese of Winchester.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the third and fourth years of Her Majesty, chapter sixty; of the Act of the eighth and ninth years of Her Majesty, chapter seventy; and of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five, duly prepared and laid before Her Majesty in Council, a representation bearing date the eleventh day of July, in the year one thousand eight hundred and sixty-one, in the words and figures following;

that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the third and fourth years of your Majesty, chapter sixty; of the Act of the eighth and ninth years of your Majesty, chapter seventy; and of the Act of the nineteenth and twentieth years of your or plan hereunto annexed, and are thereon colored

Majesty, 'chapter fifty-five, have prepared, and now humbly lay before your Majesty in Council, the following representation for altering the boundaries of the new parish of Christ Church, Paddington, in the county of Middlesex, and in the diocese of London.

"Whereas by the authority of an Order of your Majesty in Council, bearing date the twenty-fifth day of February, in the year one thousand eight hundred and fifty-six, and duly published in the London Gazette on the seventh day of March in the same year, a portion of the parish of Saint James, Paddington, in the said county and diocese, was assigned as a district to the consecrated church called Christ Church, situate at Craven Hill, in the said parish.

"And whereas the said district was called the District Chapelry of Christ Church, Paddington, and such district chapelry has, under the provisions of the Act of the nineteenth and twentieth years of your Majesty, chapter one hundred and four, since become a new parish, such as is contemplated by the Act of the sixth and seventh years of your Majesty, chapter thirty-seven.

"And whereas it has been proposed to us, and it appears to us to be expedient that the boundaries of the said new parish of Christ Church, Paddington, should be altered as hereinafter mentioned.

"Now, therefore, with the consents of the Right Honorable and Right Reverend Archibald Campbell, Bishop of London, and in right of his See, the patron of the said parish of Saint James, Paddington, and of the said new parish of Christ Church, Paddington, of the Reverend Archibald Boyd, the incumbent of the said parish of Saint James, Paddington, and of the Reverend Richard Wood, the incumbent of the said new parish of Christ Church, Paddington (in testimony whereof they have respectively signed and sealed this representation) we humbly represent that it would in our opinion be expedient that the boundaries of the said new parish of Christ Church, Paddington, should be altered so as to exclude from such new parish all that part thereof which consists of a piece or parcel of ground, upon which parochial schools are intended to be erected, comprising by admeasurement nineteen perches, or thereabouts, and situate on the western side of the street or road called Craven-terrace, and which is bounded as follows, that is to say; on the south, by a straight line extending along the northern boundary wall of the house and premises Number 9, Craven-terrace, and of the mews or stables in the rear thereof, for a distance of ninetynine feet, measured from the boundary in the middle of Craven-terrace aforesaid, which divides the said new parish from the parish of Saint James, Paddington aforesaid; on the north by another straight line extending along the southern boundary walls of the house and premises Number 5, Craven-terrace, and of the garden attached to the house Number 1, Craven-hill, for a distance of one hundred and thirteen feet and five inches, measured from the said boundary between the new parish and parish of Saint James, aforesaid; and on the west by a straight line drawn from the western end of the before-mentioned straight line, measuring ninety-nine feet, to the western end of the secondly mentioned straight line measuring one hundred and thirteen feet and five inches as aforesaid; and also all that part of the said new parish which consists of that portion of the footpath and roadway of Craven-terrace aforesaid, which abuts as frontage upon the firstdescribed piece or parcel of ground. (All which parts are more particularly delineated on the map
