THE Queen has been pleased to order a congé d'élire to the Dean and Chapter of the cathedral church of Durham, empowering them to elect a Bishop of that See, the same being void by the death of the Honourable and Right Reverend Father in God Doctor Henry Montagu Villiers, late Bishop thereof; and Her Majesty has also been pleased to recommend to the said Dean and Chapter the Right Reverend Father in God Doctor Charles Baring, now Bishop of Gloucester and Bristol, to be by them elected Bishop of the said See of Durham.

THE Right Honourable the Lords of the Committee of Privy Council for Trade have received, from the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Consul at Lisbon, enclosing copies of Notices issued by the Portuguese Board of Health, declaring that the Port of St. Nazaire is considered suspected of yellow fever, and that the Port of Mossamedes is considered free from the disease since the 24th June last.

THE Right Honourable the Lords of the Committee of Privy Council for Trade have received, from the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Ambassador at Paris, enclosing a copy of a French Imperial Decree authorizing the importation, free of duty, under the conditions specified by Article V of the law of 5th July, 1836, of pieces of unbleached tissues of wool, pure or mixed with cotton, hair, or silk, intended to be printed in France for re-exportation only.

The re-exportation of the tissues, when printed, must take place within a period in no case exceeding six months.

THE Right Honourable the Lords of the Committee of Privy Council for Trade hereby give notice, that the Moniteur of the 5th instant contains a French Imperial Decree, fixing, according to a Tariff annexed to the Decree, the amount of the ton of freightage in regard to which, according to the length of the ship's voyage, the surtax of 10, 20, and 30 francs per ton is charged upon foreign vessels, importing foreign goods into the French colonies of Martinique, Guadaloupe, and Reunion, or exporting to France the products of those colonies.
