IN pursuance of the provisions contained in an Act of Parliament, made and passed in the forty-second year of the reign of His late Majesty King George the Third, intituled "An Act for dividing and enclosing the commons and waste lands within the manor and parish of Handsworth, in the county of York," I, the undersigned, the Reverend John Hand, of Handsworth aforesaid, Clerk, Rector of the said parish of Handsworth, do hereby give notice that I intend, by writing under my hand, to apply to the next General Quarter Sessions of the Peace, to be holden at Pontefract, in and for the West Riding of the county of York, to have two persons named and appointed by the justices then and there assembled, to be, together with a third person to be named and chosen by such two persons, arbitrators or referees for enquiring into and ascertaining, by

the ways and means mentioned in the Act, the average price of a Winchester bushel of good marketable wheat, within the said county of York, for the seven years then last past, for the better regulation of the corn or tithe rents issuing and made payable out of the lands and estates lying within the parish of Handsworth aforesaid, under and by virtue of the said Act.—Dated this 14th day of January, in the year of our Lord, one thousand eight hundred and sixty-two.
