WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her Majesty, chapter forty-nine; and of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five, duly prepared and laid before Her Majesty in Council a representation, bearing date the twelfth day of December, in the year one thousand eight hundred and sixty-one, in the words following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of your Majesty, chapter forty-nine; and of the Act of the nineteenth and twentieth years of your Majesty, chapter fifty-five, have prepared, and now humbly lay before your Majesty in Council, the following representation as to the assignment of a district chapelry to the consecrated church called Christ Church, situate at Lumley, in the parish of Chester-le-Street, in the county of Durham, and in the diocese of Durham.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church called Christ Church, situate at Lumley aforesaid.

"Now, therefore, with the consent of the Right Reverend Charles, Bishop of Durham, testified by his having signed and sealed this representation, we humbly represent that it would, in our opinion, be expedient that all those several portions of the said parish of Chester-le-Street, described in the schedule hereunto annexed, all which portions, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto also annexed, should be assigned to the said church, and that the same should be named 'The District Chapelry of Christ Church, Lumley.'

"And, with the like consent of the said Charles, Bishop of Durham, testified as aforesaid, we further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at such church, and that the fees to be received in respect thereof, should be paid and belong to the minister of the same church for the time being.

"We, therefore, humbly pray, that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such order with respect thereto, as to your Majesty in your Royal wisdom shall seem meet.
