

allotment numbered 505 upon the same maps; and extending thence north-eastward along the middle of such fence and of the fences which divide the allotment numbered 507 upon the said maps and the close numbered 502 upon the same maps from the allotment numbered 505 as aforesaid, and from the allotments numbered respectively 506 and 504 upon the said maps, and the close numbered 503 on the same maps, to a point in the middle of the eastern end of the fence which divides the close and premises numbered 540 upon such maps from the close numbered 503 as aforesaid, and extending thence, first westward and then northward; along the middle of such last described fence, and of the fences which divide the closes numbered respectively 544, 543, 546, 547, 548, 563, and 559 on the said maps, from the closes numbered respectively 501, 499, 549, and 558 upon the same maps, to a point in the middle of the road leading from Sawbridgeworth to Allen's-green, opposite to the middle of the northern end of the last described fence, dividing the close numbered 559 from the close numbered 558 as aforesaid, and extending thence in a direction first westward and then northward along the middle of the last-mentioned road, as far as a point in the middle of the bridge which carries such road over the brook, formerly called 'Belcomstead Slough,' and extending thence north-eastward up the middle of such brook, to a point in the middle of the lane leading from Tharbles, past the farm premises called or known as 'Sweetdews Farm,' and past the house and premises called or known as 'Sacombe's Ash,' to Much Hadham, and extending thence in a direction generally north-westward along the middle of the last-mentioned lane to the boundary dividing the said parish of Sawbridgeworth from the parish of Much Hadham, in the county of Hertford, and in the diocese of Rochester aforesaid, at a point in the centre of the bridge which carries such lane over a certain stream flowing from the north of the parish of Sawbridgeworth, into the parish of Gilston."

Her Majesty, having taken the said representation, together with the map or plan thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof; and to order, and it is hereby ordered, that the proposed assignment of a district chapelry to the consecrated church of Saint James, situate at High Wych, in the parish of Sawbridgeworth, in the county of Hertford, to be called "The District Chapelry of Saint James, High Wych," be accordingly made; and that the recommendations of the said Commissioners, with reference to the publication of banns, and the solemnization of marriages, baptisms, churchings, and burials in the said church, and with reference to the fees to be paid in respect of those offices, be carried into effect agreeably to the provisions of the said Acts; and Her Majesty is further pleased to direct that this Order be forthwith registered by the Registrar of the diocese of Rochester.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the third and fourth years of Her Majesty,

chapter one hundred and thirteen, of the Act of the fourth and fifth years of Her Majesty, chapter thirty-nine, and of the Act of the twenty-third and twenty-fourth years of Her Majesty, chapter one hundred and twenty-four, duly prepared and laid before Her Majesty in Council a scheme, bearing date the twenty-third day of January, in the year one thousand eight hundred and sixty-two, in the words following, that is to say;

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the third and fourth years of your Majesty, chapter one hundred and thirteen, of the Act of the fourth and fifth years of your Majesty, chapter thirty-nine, and of the Act of the twenty-third and twenty-fourth years of your Majesty, chapter one hundred and twenty-four, have prepared, and now humbly lay before your Majesty in Council, the following scheme for making better provision for the cure of souls in the new parish of Saint Paul, Armitage Bridge, in the county of York, and in the diocese of Ripon.

"Whereas the church of the said new parish of Saint Paul, Armitage Bridge, is in the patronage of the vicar or incumbent for the time being of the vicarage of the parish of Almondbury, in the county and diocese aforesaid.

"And whereas John Brooke, of Armitage Bridge aforesaid, Esquire, has been the principal contributor to the cost of erecting the church of the said new parish, and has also provided a house of residence for the incumbent thereof, and he has also paid to us a sum of one hundred and twenty pounds sterling, upon the understanding that the income of the incumbent of such new parish, when the alteration in the exercise of the patronage thereof, hereinafter recommended and proposed, shall have been made, should be augmented by an equivalent annual grant to be payable out of the Common Fund under our control, in manner hereinafter mentioned.

"Now, therefore, with the consent of the Right Reverend Robert, Bishop of Ripon, and of the Reverend Lewis Jones, the present vicar or incumbent of the vicarage of the parish of Almondbury aforesaid (in testimony whereof they have respectively signed and sealed this scheme) we humbly recommend and propose, that the right of patronage of the said new parish of Saint Paul, Armitage Bridge, and of the nomination of the incumbent thereto and to the church thereof, shall, without any conveyance or assurance in the law, other than this scheme, and any duly gazetted Order of your Majesty in Council ratifying the same, and upon and from the day of the date of the publication of such order in the London Gazette, be vested in, and that it shall and may be from time to time exercised jointly by the incumbent for the time being of the vicarage of the parish of Almondbury aforesaid, and by the said John Brooke, his heirs and assigns.

And we further recommend and propose, that in consideration of the payment to us of the sum of one hundred and twenty pounds as aforesaid, there shall be paid by us, out of the Common Fund aforesaid, in each and every year by equal half-yearly payments on the first day of May and the first day of November, to the incumbent for the time being of the said new parish of Saint Paul, Armitage Bridge, the sum of four pounds, and that in case a vacancy in the incumbency of such new parish of Saint Paul, Armitage Bridge, shall happen on any other day than the first day of May or the first day of November, the amount next thereafter payable shall be duly apportioned between and paid to the incumbent making the vacancy, or his personal representative or representatives, and the
