incumbent succeeding to such new parish: Provided always, that if it shall appear to us to be expedient at any future time that, instead of the annual sum then in course of payment by us to the incumbent of the said new parish, or instead of any part of such annual sum, any land, tithe, or other hereditament, should be conveyed or secured to such incumbent and his successors in fee, nothing herein contained shall prevent us from recommending and proposing such a substitution.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or either of them, or of any other Act of Parliament.',

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the diocese of Ripon.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the third and fourth years of Her Majesty, chapter sixty; and of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five, duly prepared and laid before Her Majesty in Council a representation, bearing date the twenty-third day of January, in the year one thousand eight hundred and sixty-two, in the words following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the third and fourth years of your Majesty, chapter sixty; and of the Act of the nineteenth and twentieth years of your Majesty, chapter fifty-five, have prepared, and now humbly lay before your Majesty in Council, the following representation as to the assignment of a district chapelry to the consecrated church of the Holy Trinity, situate at Toxteth Park, in the chapelry district of Saint James, Toxteth Park, in the county of Lancaster, and in the diocese of Chester.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of the Holy Trinity, situate at Toxteth Park aforesaid.

"Now, therefore, with the consent of the Right Reverend John, Bishop of Chester, testified by his having signed and sealed this representation, we humbly represent, that it would, in our opinion, be expedient that all those parts of the said chapelry district of Saint James, Toxteth Park,

and of the district chapelry of Saint Matthew, Toxteth Park, in the county and diocese aforesaid, which are described in the schedule hereunto annexed, and all which parts, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto also annexed, should be assigned to the said church of the Holy Trinity, and that the same should be named 'The District Chapelry of the Holy Trinity, Toxteth Park.'

"And, with the like consent of the said John, Bishop of Chester, testified as aforesaid, we further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, and churchings, should be solemnized or performed at such church, and that the fees to be received in respect thereof should be paid and belong to the minister of the same church for the time being: Provided always, that so long as the Reverend Lewis Frederic Thomas, the present incumbent of the said chapelry district of Saint James, Toxteth Park, shall continue to be such incumbent, all the fees which shall be payable in respect of the performance of the said offices in the said church of the Holy Trinity, Toxteth Park aforesaid, shall be paid by the said minister thereof to the said Lewis Frederic Thomas.

"We, therefore, humbly pray, that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such Order with respect thereto as to your Majesty in your Royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of the Holy Trinity, Toxteth Park, being:—

"All that part of the chapelry district of Saint James, Toxteth Park, in the county of Lancaster, and in the diocese of Chester, which is situate to the west of an imaginary line, commencing on the boundary dividing the said chapelry district from the district chapelry of Saint Matthew, Toxteth Park, in the same county and diocese, at a point in the middle of the eastern end of Stanhope-street, and extending thence north-westward to and along the middle of Saint James's-place, to the boundary dividing the said chapelry district of Saint James, Toxteth Park, from the parish of Liverpool, in the same county and diocese; and also all that part of the said district chapelry of Saint James, Toxteth Park, which is situate to the west of the district chapelry of Saint Matthew, Toxteth Park aforesaid; and also all that part of the said district chapelry, of Saint Matthew, Toxteth Park, which is situate to the west of an imaginary line extending along the middle of Bedford-street."

Her Majesty, having taken the said representation, together with the map or plan thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, and it is hereby ordered, that the proposed assignment of a district chapelry to the consecrated church of the Holy Trinity, situate at Toxteth Park, in the chapelry district of Saint James, Toxteth Park, in the county of Lancaster, to be called "The District Chapelry of the Holy Trinity, Toxteth Park," be accordingly made; and that the recommendations of the said Commissioners with reference to the publication of banns, and the solemnization of marriages, baptisms, and churchings, in the said church, and with reference to the fees to be paid in respect of those offices, be carried into effect agreeably
