carry such povisions into effect by any mode of payment, contribution, augmentation, or endowment which may be deemed fit;

"And whereas upon the vacancy of the Deancry of the Cathedral Church of Exetor, which occurred on or about the seventeenth day of January, in the year one thousand eight bundred and sixtyone, by the decease of the Very Reverend Thomas Hill Lowe, the then Dean, the representatives of the said Thomas Hill Lowe became entitled, in accordance with the ancient statutes, usages, and customs of the said Cathedral Church, to receive the share of the corporate revenues of the said Cathedral Church of Exeter, belonging to the deanery during the period intervening between the decease of the said Thomas Hill Lowe and the twenty-fifth day of March, one thousand eight hundred and sixty-two;

"And whereas the Very Reverend Charles John Ellicott, the present Dean of the said Cathedral Church, was appointed to such deanery on or about the twentieth day of June, one thousand eight hundred and sixty-one, but by reason of the ancient statutes, usages, and customs above referred to, he will not be entitled to receive any portion of the revenues of the said Cathedral Church during the period which will have elapsed between the date of his appointment and the twenty-fifth day of March uext, the date at which the representatives of the said Thomas Henry Lowe will cease to be entitled to any portion of the said capitular revenues, and by reason of the alteration in the mode of appointing the Dean, made by the firstly hereinbefore mentioned Act, the representatives of the present dean and his successors, will not be entitled to any portion of the corporate revenues of the said chapter which may accrue after any avoidance of the deanery ;

"Now therefore we humby recommend and propose, that there shall be paid by us to the present Dean of the said Cathedral Church of Exeter, in respect of the period which will have elapsed between the date of his appointment to the said deanery as aforesaid, and the said twenty-fifth day of March next, a sum calculated at and after the rate of one thousand pounds per annum;

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in conformity with the provisions of the said Acts, or of any other Act of Parliament."

And whereas the said scheme has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same, and every part thereof, shall be effectual in Iaw, immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct, that this Order be forthwith registered by the Registrar of the Diocese of Exeter. *Edmund Harrison*.

W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the eighth and ninth years of Her Majesty, No. 22611. B

chapter seventy; and of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five, duly prepared and laid before Her Majesty in Council a representation, bearing date the thirteenth day of February, in the year one thousand eight hundred and sixty-two, in the words and figures following; that is to say: "We, the Ecclesiastical Commissioners for

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the eighth and ninth years of your Majesty, chapter seventy, and of the Act of the nineteenth and twentieth years of your Majesty, chapter fifty-five, have prepared and now humbly lay before your Majesty in Council, the following representation as to the assignment of a consolidated chapelry to the consecrated church of Saint Peter, situate at Draycott, in the parish of Cheddar, in the county of Somerset, and in the diocese of Bath and Wells.

"Whereas at certain extremities of the said parish of Cheddar, and of the parish of Rodney Stoke, in the county and diocese aforesaid, which lie contiguous one to another, and are described in the schedule hereunder written, and also in the contiguous extra-parochial place called or known as Nyland and Batcombe, in the same county and diocese, there is collected together a population which is situate at a distance from the respective churches of the said parishes of Cheddar and Rodney Stoke.

"And whereas it appears to us to be expedient that such contiguous portions of the said parishes of Cheddar and Rodney Stoke, and also the said contiguous extra-parochial place called or known as Nyland and Batcombe, should be formed into a consolidated chapelry for all ecclesiastical purposes, and that the same should be assigned to the said church of Saint Peter, situate at Draycott aforesaid.

" Now, therefore, with the consent of the Right Honourable and Right Reverend Robert John, Baron Auckland, Bishop of Bath and Wells, and, in right of his see, the patron of the rectory of the parish of Rodney Stoke aforesaid (in testimony whereof he has signed and sealed this representation), and also with the consent of the Dean and Chapter of the cathedral church of Wells, the patrons of the vicarage of the parish of Cheddar aforesaid (in testimony whereof they have hereunto affixed their common or capitular seal), we humbly represent that it would, in our opinion, be expedient that all those contiguous portions of the said parishes of Cheddar and Rodney Stoke, and also the whole of the said contiguous extraparochial place called or known by the name of Nyland and Batcombe, which are described in the schedule hereunder written, all which portions and place, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one consolidated chapelry for the said church of Saint Peter, situate at Draycott aforesaid, and that the same should be named 'The Consolidated Chapelry of Saint Peter, Draycott.'

"And we further represent that it has been mutually agreed between the said Robert John, Baron Auckland, Bishop of Bath and Wells, and the said Dean and Chapter of the cathedral church of Wells (testified as aforesaid), that the right of presentation and appointment to the church of the said consolidated chapelry of Saint Peter, Draycott, shall belong to, and be exercised alternately by, the vicar for the time being of the said parish of Cheddar, and the rector for the time being of the said parish of Rodney Stoke, respectively, and that the first turn thereof shall belong to and be exercised by the vicar for the time being of the parish of Cheddar aforesaid.
