

*Whitehall, March 19, 1862.*

The Queen has been pleased to grant unto Samuel Christy, of Priors, in the parish of Broomfield, in the county of Essex, of Britwell House, in the county of Buckingham, of Moira House, in the Green-park, in the parish of St. James, Westminster, and of Craigentenny, in the county of Mid-Lothian, Esquire, sometime Representative in Parliament for the borough of Newcastle-under-Lyme, and one of Her Majesty's Commissioners for executing the Lieutenantancy in and for the city of London, Her Royal licence and authority that he, and his issue, may, in compliance with a direction contained in a codicil to the last will and testament of Ellen Marsh, late of Britwell House aforesaid, Spinster, deceased, take, and henceforth use, the surname of Miller, in addition to, and after, that of Christy; and that he and they may bear the arms of Miller quarterly with those of his and their own family, such arms being first duly exemplified according to the Laws of Arms, and recorded in the Herald's Office, otherwise the said Royal licence and permission to be void and of none effect:

And to command that the said Royal concession and declaration be registered in Her Majesty's College of Arms.
