

*Whitehall, May 14, 1862.*

The Queen has been pleased to grant unto Thomas Fox Embleton, of Northorpe, in the county of Lincoln, Esquire, Her Royal licence and authority that he may, in compliance with a request contained in the last will and testament of Thomas Fox, late of Northorpe aforesaid, Esquire, deceased, take and henceforth use the surname of Fox in addition to and after that of Embleton, and that he may bear the arms of Fox quarterly with his own family arms, and that such surnames and arms may in like manner be taken, borne, and used by his issue, such arms being first duly exemplified according to the laws of arms, and recorded in the Herald's Office, otherwise Her Majesty's said licence and permission to be void and of none effect:

And to command that the said Royal concession and declaration be registered in Her Majesty's College of Arms.
