WHEREAS the Trustees of the Whitchurch or First District of Turnpike Road, acting under the powers of the Local Act of the 4th of George the Fourth, cap. 83, have made application to Her Majesty's Principal Secretary of State for the Home Department, pursuant to the Act of the session holden in the 14th and 15th years of the reign of Her present Majesty, cap. 38, and the Act of the 24th and 25th of Victoria, cap. 46, section 2, for a Provisional Order, to reduce the rate of interest on the mortgage debt charged or secured on the tolls or revenues of the said road, and to extinguish certain arrears of interest due upon the said debt;

Now, therefore, in pursuance of the power and authority of the said Act of the 14th and 15th of Victoria, cap. 38, given to me, as one of Her Majesty's Principal Secretaries of State, and in conformity with the said application, I do by this Provisional Order under my hand declare, -subject to the confirmation hereof by Parliament,that from the thirty-first day of December, one thousand eight hundred and sixty-one, the rate of interest shall be reduced from five pounds to three pounds per centum per annum upon the bonded or mortgage debt of one thousand four hundred and twenty-five pounds, and from four pounds ten shillings to three pounds per centum per annum upon the bonded or mortgage debt of one thousand and fifty pounds, charged or secured upon the tolls or revenues of the said road, and that the arrears of interest for one year due and remaining unpaid
