CAPTURE OF NAJAOR.

MY. LORD, Nojaor, May 17, 1862. YOU will be pleased to acquaint the Lords Commissioners of the Admiralty, that Najaor was captured this evening by the forces under the command of Brigadier-General Stavely and the French Admiral Protêt, with a loss which would have been small, had not the latter fallen at the head of his men.
