THE Right Honourable Sir George Grey, Bart., has received the following Despatches from Earl Russell:

Brussels,

SIR,

September 3, 1862.

I HAVE the honour to inform you that Her Majesty the Queen having come from Woolwich in the Fairy, embarked at Greenhithe on the 1st instant, at 5 p.m., on board the Royal yacht Victoria and Albert; Her Majesty proceeded forthwith down the river as far as the Nore, where the Royal yacht anchored for the night. On the following morning, at daylight, Her Majesty proceeded to Antwerp, where the Queen safely arrived at 4 p.m.

The Duke and Duchess of Brabant immediately proceeded on board the yacht to welcome Her Majesty.

Her Majesty disembarked at 5 o'clock, and continued her journey to the Palace of Lacken, which Her Majesty reached at 6 r.m.

Owing to the Queen's desire to travel with the strictest possible privacy, all salutes and other public marks of respect were dispensed with.

Her Majesty intends to resume her journey to Gotha on Thursday afternoon next.

I am happy to inform you that Her Majesty and the Royal Family have not suffered from the fatigues of the journey.

The Queen was accompanied to the private station of Lacken by their Royal Highnesses the Duke and Duchess of Brabant and the Count of Flanders.

The Queen quitted Cologne at 10 P.M., and shortly before 9 o'clock this morning reached Gotha, where Her Majesty was received by His Royal Highness the Duke of Saxe Coburg-Gotha.

The Queen immediately drove to the Castle of Rheinhardsbrun, where Her Majesty arrived shortly after 10 o'clock.
